I Smt. Surashree Kar, W/o- Dibangkar Dhara, resident of 3 no Neli Sengupta Sarani, Thana More, Udichi Apartment, 1st Floor, PS- Siliguri, Dist- Darjeeling do hereby lodge complain to the effect that, on 24/09/2025 morning at about 3:30 AM to 4:00 AM when we returning back from Jalpaiguri side to our destination at our house to Siliguri town with our vehicle bearing registration number HP38H6760, model name Mercedes – AMG G63 (Olive metallic color), Chassis no- WINYC7GJ1RX503079, Engine no- 17798060257273, manufactured by Mercedes- Benz AG, owners name- Technosolis Informatics Limited Comapny. Driven by my husband through NH-27. On that day when we reached at Fulbari - Ghosh pukur crossing, near Pather Sathi Restaurant at that time from the opposite side that is coming from Siliguri to Ghosh Pukur crossing one heavy loaded truck (Tailor) suddenly came with high speed and rash and negligence manner and hit our vehicle from the front side and thereby causing heavy damaged of our vehicle's front vision as well as the engine of the vehicle. And as a result my husband received severe bleeding injury on his chest, hand and other parts of the body, and the said offending truck and his driver fled away from the spot. On-duty police personnel of NJP police station and the local people immediately rushed to the spot and rescued us and shifted to nearby Maharaja Agrasen Hospital, Fulbari and after preliminary treatment observing the injury is serious in nature, we shifted my husband Dibangkar Dhara to Neotia Getwel Multispecialty Hospital, Uttorayon, Matigara, Siliguri for his better treatment and major operation were done, and now my husband is admitted in the said Hospital.


