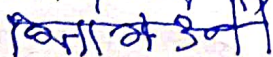
Sub - Complaint against fight and assault with

(iii). Chintu Sahani s/o Pramod Sahani (iv) Kishan Sahani
s/o Rekha Sahani (v). Manish Sahani s/o Bajrang

others with many friends using Weapons - knives, Rods,
stick and harmful weapons, etc, without any provocation.
