Respected Sir,

with due respect and humble
submission I (Sangeeta Mahato) wants to
inform you that my son was coming
home after visiting the Durga Puja's Pandal.
While returning home ^{on dated - 02-10-25 at 9:30 pm} there were total
8 to 10 highly drunk adult Boys who
just caught my son and beaten him
very badly without any reason. When
my nephew went there to ask what
happened and why are ^{they} beating him some
of them ran away. On the same day
in the Evening they called many Boys
approx 20 - 25 boys just to beat my
son again and they called my son and
told him that they will sort out this case
but without sorting anything they just
bring weapons with them (sword, knife, guns
and many other weapons). They beat my
son, nephew and when my husband went
there to sort out peacefully the group of
boys had beaten my husband very very badly
and hospitalised him. I (Sangeeta Mahato)
submitting the names of all those Boys

who was involved in that fight and hospitalised my husband, sons and nephews. The name of the boys are as follows:-

- ① Rohan Sakari (Sword in his hand)
- ② Maroj Sakari (Heavy Iron pipe)
- ③ Amit Poddar (Knife was in his hand)
- ④ Nikhil Sakari (Rambo knife was in his hand)
- ⑤ Rabi Sakari (Wooden piece was in his hand)
- ⑥ Chotu Sakari (Khukri was in his hand)
- ⑦ Suraj (Chopper was in his hand)
- ⑧ Sandip Sakari (Iron rod was in his hand)
- ⑨ Rahul Yadav (He was holding the gun)
- ⑩ Bholu Sakari (Batam was in his hand)

These are the main Boys who had hospitalised my husband, sons and nephews, and there were some more boys who are unknown to us.

I request you to please take a very strict action against these Boys.
