I Prasenjit Ghosh, the above noted complainant
beg to inform you that on 21.09.2025 at about
05 am, approx. when I went to open my Milk
products shop, (opposite Tyotinagar Colony, Ward No-4)
at that time the above noted alleged persons, started
beating brutally to my staff namely, Tapash Barman
(28) S/o Sri Shyamal Barman, of Tumulpura, Near Durga
Mander, Ward No. 81, P.S-Siliguri, in front of Tyotinagar
club at Tyotinagar Colony and when I alongwith my
wife's sister namely, Bisakha Sarkar (31) wife of Raju
Sarkar of Near Charak Maata, Tyotinagar Colony, Ward
No-4, P.S-Siliguri and my wife namely Tamushree Ghosh
(25) reached there to save my staff namely Tapash
Barman, noted above, then the above noted alleged
persons, started beating me and Bisakha Sarkar, noted
above, brutally with fist and blades and stolen away
my Gold chain & Ring and mobile phone of my staff
Tapash Barman, Vivo, loaded with sim card bearing
number No. 7883692880 (Airtel) and damaged my
scooter (ola) bearing Regd. No. WB-74-B-U-4648.

Sir, I alongwith my relative namely, Bisakha
Sarkar & my staff namely Tapash Barman (28) shifted
to Siliguri DistH. Hospital and treated ourselves there.

Sir, the above noted alleged persons are of very
desperate & dangerous in nature and they have threatened
us for dire consequences.
