Sir,

I, Amit Paul, the above noted complainant beg to inform you that I have my defuncts shop in front of Shakti Bedi, S.F. Road (Thana More) and my above noted neighbours have the same type of shop, beside my shop. Due to the Pujan season, I used to close my said shop, late night in the season.

On dt. 21-09-2025 at about 23:30 hrs, my minor daughter namely Gayatri Paul (17 yrs) who also sit on my shop with her mother namely, Asha Paul (40), got the national call and went to urinate at Hat Khola Bazar, which is nearby to my shop, at that time my neighbouring shopkeeper namely, Chandan Paul, who was already there, caught my said minor daughter and squeezed her breasts and when she anyhow released herself from his claws then he torn off her clothes and disrobed her. Therefore my said minor daughter, anyhow return to my shop, and explained about the incident to her mother, and when my wife namely Asha Paul (40), asked to (2) Pawan Paul S/o Sri Chandan Paul, (3) Pratima Paul D/o Sri Chandan Paul and (4) Smt. Milan Paul W/o Sri Chandan Paul, then they started abusing my wife in filthy languages and when she protested the above noted alleged persons started beating and bullying to my said wife namely Asha Paul, with fist & blows at my shop at Thana More (S.F. Road), and threatened them to do consequences.

My said wife received severe injury on her person and immediately shifted to Siliguri Dist. Hospital and treated myself here.

So, Please take necessary action against above noted alleged persons.
