That above named persons are my neighbours that on 29-09-2025 at about 2 p.m. I went to nature calls at the behind of my house but at that time all the above persons came to the spot and started to beat me by saying "Why I am using this area for nature calls".

That Nikita Mandal, Guriya Mandal and, mother of Amardip, were holding my hair and Amardip, Shivam Mandal random beat me on my cheek, forehead and trying to outrage my modesty and they torn my wearing apparel and mercilessly beaten me by fist and blow thereafter I became senseless as a result I got injuries on my forehead, my right leg, left hand, and nose, and belly due to injuries I became very ill and for that reason I was not able to lodged complaint on time.

Sir they always disturb me on some petty issues and taking the advantage of my helpless situation.

Sir, I therefore request you please look into the matter and take necessary action against them.
