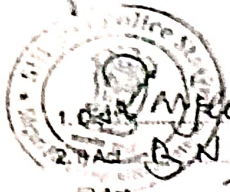

Sir,

I Prahlad Prasad Gupta S/O Lt. Bhargunath Prasad Gupta, permanently residing at Kumar Pally, Bidyanagar Road By-lane (Opp. Khatun T.O.P. II) Bidyanagar Pally, Khalpara, Ward No. 7 SMC, PO-Siruguri Bazar, P.S.-Siruguri, Distt. Durgam, aged about 59 yrs and advocate by profession beg to inform you that on 02.10.2025 at about 05:00 hrs., in the early morning, when I reached at Talpawmore (Aam Vegetables Market) after running the Deurga Puja Pandale, I saw that 02 (two) unknown persons in very injured condition, were lying at road side & nearer to them a badly damaged white motor cycle bearing Regd. No WB-74-BN-1473, was also lying.

Sir, it seems that the said unknown persons were rider of the said motor cycle and another one was a pedestrian, to whom the said rider of the motor cycle, badly hit driving in a rash & negligent way. Or, any other unknown vehicle badly dashed said motor cycle rider and the pedestrian driving in a rash & negligent way and injured the both persons, and damaged the said motor cycle.

Whoever may be the victims or offender Either, the unknown driver of the said motor cycle OR the driver of the opposite side's unknown vehicle, I think that being the advocate of Siruguri Court and a responsible citizen of the locality, it is my duty to inform you.

So, kindly investigate into the matter and take necessary action.
