
In producing herewith three detained persons namely Debjit Chakrabarty, Amit Das and Prasenjit Sarkar, I Armed SI Magan Gurung of NJP Traffic Guard, SPC do hereby lodge this complaint against the above named three persons and 2(two) others to the effect that on 30.09.2025 I was performing traffic regulation duty at GREF more along with C/1580 Chandan Gurung, C/1508 Md Alimul Islam and CV/32 Mithun Roy in c/w Durga Puja festival-2025. Since on 30.09.2025 was Maha Asthami festival, huge vehicular congestion was taken place on the way from Tinbatti more to Central Colony Puja Pandal side. At about 11.30 pm, three persons arrived by availing a vehicle no WB 74 N 9571 (WagonR). Since the vehicle went out of order in the vehicular queue, a huge jam was taken place due to this. We asked them to keep the vehicle aside to avoid vehicular obstruction. But the persons including a women accompanied them were in highly intoxicated state upto the brim and picked up quarrel with us. We repeatedly requested them not to obstruct us in discharge of our lawful duty. But they remained in different and continued their misdeeds and assaulted me with ~~fixed~~ ^{fire} and blow by gripping my uniform color. I was about to fell down and somehow managed to control balance. Local residents have seen and became witness of the entire fact. I somehow escaped from the place to save my life and went to NJP TG. After a while again noted three persons came to the TG and began to altercate with in a state of drunkenness and physically beaten me. I informed my superiors and in the mean time, NJP Mobile van rushed to the TG and took them in the custody red handed in committing cognisable offences.

Thus the above noted three persons and two others committed offences of lawful obstruction of public servant to deter me from discharging lawful duties, assault and wrongful restraint.

I therefore, pray that specific case may kindly be started under appropriate section of law.
