Respected Sir,

I Harekrishna Das, Son of Late Santosh Kumar Das, Resident of New Telipara, do hereby inform you that my son name Rahul Das (Raj), aged about 23, on 1st Day of October, 2025, he along with his group of friends went for pandel hopping. Friends namely 1. Antar Sarkar, Son of Jiban Kumar Sarkar, 2. Ajay Bala, Son of Ashok Bala, 3. Pappu Roy, 4. Subhajit Das, Son of Sanjay Das, 5. Biswa (Poltu), 6. Mintu, as stated by the group of friends they had a plan to visit Firengee Pub & Restaurant, and directly other friends had joined in the Restaurant as stated above at around 12:30 am, on 1st Day of October, 2025.

There Rahul Das (Raj) parental aunt's son named as Bapi Srivastav, Son of Som Srivastav, Resident of Bhanu Nagar and 2 girls along with him were also present at the Firangi Pub & Restaurant one named as Ruhi Das, Resident of Shaktighar, and the other was unknown, after that my son had joined Bapi Srivastav and his group and had separated his table with his group of friends and had choosed to join Bapi Srivastav and his group. There after at around 2:30 A.M, Rahul Das (Raj) group of friends had insisted Rahul to join them for pandel hoping as they had pre-planned but Rahul refused to go with his friends and had choosed to stay with his elder brother Bapi Srivastav and accordingly his Rahul Das group of friends left him with his elder brother at Firangi Pub & Restaurant and thereafter suddenly at around 2:45 A.M. Rahul Das (Raj) group of friends saw Rahul near COSMOS Mall, Sevoke Road, with one of the girl namely Ruhi Das who was present in that Pub & Restaurant along with his elder brother. Thereby his group of friends asked Rahul to join them and upon that Rahul replied that he will drop Ruhi Das to her residence safely and join them as soon as possible, At around 2:50 A.M. one of his friend Subhajit Das friend of Rahul called him and on that call Rahul Das (Raj) asked immediately to come near Sevoke More as his voice and sound of the surrounding environment seems that he might be in trouble with some miscreants.

His group of friends immediately rushed towards Sevoke More and tried calling him several times, but after few repeated calls Ruhi Das received the call and informed that Rahul met with an accident and asked to come in King's Hospital, Thereafter his friends rushed towards the hospital and found Bapi Srivastav and his group of 2 girls were also present at the King's Hospital. And my son Rahul Das (Raj) was lying in stretcher, full of blood, shivering his body in a crucial and critical condition, Doctor's of that Hospital refused to cure such severe and critical condition and accordingly his group of friends had arranged an ambulance and had immediately rushed Rahul to Neotia Hospital which is one of the renowned Hopsital in the city, thereby Bapi Srivastav and his group of 2 girls had escaped from King's Hospital and Bapi Srivastav had informed my elder son namely Raja Das about an accident at around 3:30 A.M., after receiving such information my elder son Raja Das rushed towards the hospital and found his younger brother in an ambulance in a critical and severely injured condition and had rushed him to Emergency immediately and Doctor's of that Hospital stated to my elder son Raja Das that this is not an accidental case, rather this is a case of violence and assault and thereby started his treatment at around 3:45 A.M, Due to loss of huge quantity of blood from the body, there was in need of 8 bottles of blood immediately. And accordingly he was shifted in I.C.U and after arranging of the blood his surgery would possibly be arranged. Thereafter my elder son informed about the incident to us and other family members. My younger sons friends have disclosed and narrated about the entire incident and the scenario they have witnessed to my elder son. Thereafter suddenly at around 4:45 A.M. to 5:00 A.M. Bapi Srivastav came in Neotia Hospital to justify the scenario and circumstances of the situation and condition of my younger son Rahul Das. My elder son upon asking him about the scenario as he was with him since the beginning and upon asking the girl Ruhi Das details he became violent and aggressive towards my elder son friend's and thereby ended up assaulting to his group of friends. My elder son settled the dispute and asked Bapi Srivastav to leave the place. Since then Bapi Srivastav didn't even came for once within these days, and upon asking him to come during these days for asking about the scenario he always refused to come or have any excuse that restrained him to come to my house which makes it suspicious. We suspect that Bapi Srivastav and Ruhi Das know the actual reason for the death. Furthermore, this is not a case of an accident as claimed by them, and we suspect Bapi Srivastav and Ruhi Das are behind my younger son's death. While arranging the blood doctors had informed at about 8:15 A.M. to one of his friend that my younger son Rahul Das (Raj) is no more and had left for abode.

This is an humble application before the concerned authority to kindly accept this application and to deeply investigate the matter and other do other needful with high concern and we are ready to co-operated, support and help the investigation team and to ensure my younger son's soul to get justice for the unjustified act done to him as earliest.
