I, Prati Mahato, aged 16 residing at (Siliguri, Pradhan Naga
Nivedita road, near gramini bank), would bring to your notice
that despite a previous case already registered against my
mother (Punam Mahato) for physically, verbally & mentally assual-
ting me.

Earlier, I had lodged a formal complaint regarding the
brutal physical violence, at your police station. But then,
she was released on bail.

Now, she had resumed her violent behaviour. On (3-10-25),
she choked my grandmother's neck against the wall and then
we shouted, she ran away. Then my father, he dialed 100.
When the concerned police officers went, she then hit me on
my upper body brutally and attempted to push me from the
upstairs terrace, but somehow my brother managed to save me.
After this, she started to abusive language (calling me Randi, et
many times).

All this ill act are recorded in the mobile camera for pursua
she has also brought a minor child in illegal act without
due care of his education, she asked him to bring a rod and
beat my brother.

Her actions have caused us some injuries ~~at~~ and have also created a unsafe environment at home.

Therefore, I request you to kindly take actions against her for repeating the offense despite being in bail.

I thereby request you to take some steps to prevent further assaults.
