With respect I, **SMT. PUNAM KUMARI MAHATO**  
**@PUNAM** Wife of Sri Sunil Mahato, Residing at Champasari  
More, Nivedita Road, Mahato Atta Chaki, Near Gramin Bank,  
Pradhan Nagar, P.O. & P.S. Pradhan Nagar, Siliguri, District-  
Darjeeling, West Bengal would like to bring to your kind notice to  
the following facts :

1. That I was married with Sri Sunil Mahato, Son of Late Jagadish Mahato on 8th June, 2006 and the said marriage was an arrange marriage and solemnized at Rajdeep Bhawan, Harekrishna Pally, Bagdogra, as per Hindu rites and customs and accordingly out of the said marriage one daughter namely, Priti Mahato (presently aged about 17 years) and one son namely, Yash Mahato (presently aged about 15 years) were born.
2. That after marriage I went to my above mentioned matrimonial house which is a joint family consisting of mother-in law, father in law and other in laws.
3. That after few days of marriage frequently I was mentally and physically tortured by my husband Sri Sunil Mahato, my mother-in law namely **SMT. SUNAINA MAHATO** and other in laws over which I lodged several complaints before the police authorities, NGO etc. and Siliguri Women P.S. Case No.49/13 under Section 498-A/ r/w section 3 and 4 of Dowry Prohibition Act, Pradhan Nagar P.S. Case No. 863/2022, dated 24.10.2022, u/s 341/323/354/506 of I.P.C were started against my husband Sri Sunil Mahato, my mother-in law namely **SMT. SUNAINA MAHATO** and other in laws.

4. That I also filed M.R Case No.114/2025 u/s 144 of B.N.S.S, C.R Case No.1092/2025 for offence committed u/s 316(2) / 3(5) of B.N.S and Misc. Case No. 27/2023 u/s 12 of the Protection of Women from Domestic Violence Act, 2005(43 of 2005) against my husband Sri Sunil Mahato, my mother-in law namely **SMT. SUNAINA MAHATO** and other in laws which are pending before the court of Ld. Judicial Magistrate(3<sup>rd</sup> Court), Siliguri.
5. That as I am not allowed in my matrimonial house to interact with my daughter & son so my husband Sri Sunil Mahato, my mother-in law namely **SMT. SUNAINA MAHATO** and other in laws injected the mind of my daughter & son with such kind poison that presently my daughter & son also started to misbehave with me & I became a helpless mother to see my daughter & son is maintaining distance with me and avoiding me.
6. That on 03/10/2025 at about 11.00 A.M while I was sitting in the rooftop of my matrimonial house suddenly my husband Sri Sunil Mahato, my mother-in law namely **SMT. SUNAINA MAHATO** , my daughter & son came there and my husband Sri Sunil Mahato, son namely Yash Mahato & daughter namely Priti Mahato started to physically assaulted me by fists & blows and my son namely Yash Mahato with an intention to kill me assaulted me with a wooden stick all over my body and on my head as a result of which I sustained cut injury on my head & I was profusely bleeding from my head. My daughter namely Priti Mahato also assaulted me by pelting stone & household utensils on me & my mother-in law namely **SMT. SUNAINA MAHATO** shouted "**Mar Do, Mar Do**". Somehow I managed to escape and my neighbor namely Siddharth Mahato took me to Siliguri District Hospital for medical treatment where I was admitted on 03/10/2025 and after medical treatment discharged on 04/10/2025 at about 11.30 A.M.
- 7, That I reasonably apprehends that the aforesaid persons will make further attempt to murder me and I live my life in great danger.
