Respected Sir,

I Sahida Khatun wife of Md. Jahid aged about 26 years, Muslim by faith, house wife by occupation, resident of Vivekananda Nagar, Rail Line, Ward No. 7 of Siliguri Municipal Corporation, P.O. Siliguri, Dist. Darjeeling would like to submit you that on 01-10-2025 at about 6:30 a.m. my husband namely Md. Jahid aged about 32 years and his one friend Md. Jabbar went to purchase milk from Jhankar More by riding his Motor bike bearing no. WB 73L9/662 while he was returning from Jhankar More after purchasing milk and when he reached near Jhankar More Traffick Point at that time suddenly one Bus bearing no. WB-73D/4519 was coming from Jalpaimore side with rash and negligent manner and dashed my husband's Motor Cycle and he fell on the road and sustained severe injuries on his head, left eyes and some local people rescued my husband and admitted to Siliguri Dist. Hospital but due to his serious condition he was taken to Sanjeevani Neuro and Multi Speciality Hospital situated at Sevoke Road, Siliguri and his condition is very critical, and my husband is fighting with death, and pillion rider Md. Jabbar sustained injuries. I heard from the local people that the accident took place due rash and negligent driving of the Bus driver bearing No. WB-73D/ 4519 (Bus) there was no fault of my husband.

Sir, due to serious condition of my husband, I was busy for the treatment of my husband and for this reason on 01-10-2025 I could not able to lodge F.I.R against the Bus Driver.

Sir, I therefore request you please look into the matter and take necessary action against the Bus Driver.
