Subject: FIR

Respected Sir,

I, Gobinda Basfore, son of Jogi Basfore, resident of Lal Diesel Colony, near Biplab Sporting Club, P.O. Pradhan Nagar, P.S. Pradhan Nagar, Siliguri – 734003, beg to lodge the following complaint for your kind action.

That, on 29.09.2025 at about 12:51 a.m., my younger brother Gulsan Basfore had gone with his TOTO to carry passengers during Durga Puja. At that time, the following accused persons: namely 1. Bikash Routh @ Natu, resident of Mahanda Colony, near Banimandir School, 2. Brindra Das @ Kalu, resident of South Ambedkar Colony, 3. Prasanjit Paswan, resident of Lal Diesel Colony, using the mobile phone of Rohit Paswan, called my brother namely Gulsan Basfore and without any reason started abusing me in filthy language. When my brother disconnected the call, they again called and threatened that if he did not come to Biplab Sporting Club, they would come to our house and assault him. Out of fear, my brother went near the club, where the accused persons started abusing him and demanding money which he had earned from his day's work. At that time, a sum of ₹2000/- (Two Thousand only) was also found missing during the incident.

When I reached there and tried to intervene, the accused persons assaulted both me and my brother. On getting information, my elder brother Goutam Basfore came to the spot to pacify the matter, but accused Brindra Das, Prasanjit Paswan and Bikash Routh attacked him with a bamboo stick on his head, causing serious injury due to which he fell down unconscious.

When my mother and sister Puja Basfore came to rescue, the accused persons also assaulted them. My sister was beaten badly, dragged by her hair, and struck on her chest and stomach. When my mother tried to save us, she too was beaten and became unconscious on the spot.

Thereafter, the accused persons continued to assault me and my younger brother. Later, at about 3:05 a.m., I along with my brother and mother went to Pradhan Nagar Police Station to report the matter. Meanwhile, at about 3:21 a.m., my younger sister Juli Basfore called us and informed that the accused persons had gone to our house armed with swords, knives, and other weapons, threatening not to lodge any police case.

They also threatened to kill our entire family and to rape my younger sister if any complaint was made. We returned home from the police station but my elder brother Goutam Basfore did not return home due to fear of the goons.
