With due respect:- I Sharada Chellai w/o, late. Atiun Chellai, R/o, Sai Complex, Bho la Chaman Road, Gital Panch Road, W.No - 41, Thana Bhakti-nagar, Dist. Jalpaiguri, West Bengal.

On the date 14.09.2025 my husband expired from the date mention above both my sister-in-law Savita Sharma, w/o, Kritan Sharma started mental torments and used abusive language on me and started staying at my residence from that day onwards. and she also take away my husband's ATM card / Mobile / Pass book / Gold ring (2) / Mangalsutra / hair / plus Rs. 1,50,000/- cash with four wheeler R.C No. WB-74-AD-4650 which she had kept it in her garage.

Last night i.e 04th Oct. 2025 on returning from my parents house, Savita Sharma with my mother-in-law started to tormenting me again with abusive language and raised hands on me and when my neighbour saw the incident they informed my sister and they arrived to rescue me and my son. They had used water bottle to hit me on my back side & on head. for which I had furnished my medical report for the same. When my son objected this Savita Sharma hit my son's fingers as well. and she also raised her hands on my sister as well.

She took me there after the death of my husband all his remaining cash

Cash and Assets will go to her and she told me and my son to go away from my home.

On the date of 14/09/2025 while receiving the death body of my husband from Anand Loh Hospital, she started hulkas in the hospital and she also do the road blocked outside the hospital and, created traffic hulkas on this day.

She further threatened my life and my son's life. and for this my neighbors are witnessing for the same.
