Respected Sir,

I (Sarika Sharma Chhetri) w/o Pritham Sharma resident of Baikunthapally ward no-41 of S.M.C P.O-Senok Road, P.S- Bhaktinagar Dist- Talpaiguri, Most respectfully submit the following for your urgent attention and necessary action.

1. My only brother Arjun Chhetri passed away on 14.09.2025. My mother aged about 70 years is a heart patient and is both physically and mentally unstable due to this tragic loss.
2. I, along with my elder sister have been staying with my mother's house at Haiderpara for some days to provide her emotional support.
3. Yesterday my brother's wife Sarika Chhetri @ Sarika went to her mother's house at Milan More under Pradhan Nagar Police Station, despite my mother's repeated requests not to leave the house due to mourning rituals.
4. After returning home late night, my mother merely asked her why she ignored her words and said that her mother could have come instead.

5. Suddenly, my bhabhi locked herself inside her room, & started shouting from balcony & called neighbours and her sisters & brothers through phone call who live at Milan More.
6. Without our consent several neighbours entered the house. My bhabhi falsely accused us of torturing her, shortly afterward, her sisters, brothers & brothers wife came and violently attacked me.
7. They bit me, slapped me, tore my clothes and I started bleeding from my face and chest area, I have multiple injuries on my body.
8. ~~Her~~ They also snatched and pushed my 10 years old daughter causing her physical pain and fear.
9. During this ~~accus~~ assault, they hit my old mother with water bottle, as she is heart patient this attack caused her extreme shock and distress, & serious or fatal injury.
10. Their brutality and the way they attacked clearly ~~show~~ show an intention to kill me and harm my mother. My mother often stays alone at home and I am afraid these persons may again attack or kill me and my mother, as they openly threatened to kill us.

Therefore, I request you to,

* kindly register an FIR immediately under appropriate sections including 307 IPC (attempt to murder) and provision relating to assault on minor child ~~or~~ child & senior citizen.

* Provide Police Protection to my mother & my family.

* Take strict legal action against all accused persons:-
