Under instructions and on behalf of **Reliance Retail Limited**, a company incorporated under the Companies Act, having its registered office at RRL FRL BF Kolkata, Salt Lake, Stadium 3B, Rammohan Mullik Garden Lane, Opposite Salt Lake Stadium, Kolkata - 700019, West Bengal, I, **Sanjit Saha**, S/o **Gopal Saha**, residing at Mail Road, Pati Colony, Siliguri Junction - 734003, West Bengal, working as **Store Manager, Reliance Retail Limited, Smart Point, Debangon Hospital Building, Swami Vivekananda Sarani, Satyajit Sarani, Bairatisal, West Bengal - 734011** (hereinafter referred to as "the Company"), do hereby lodge this complaint as under:

1. The above-mentioned store is situated within the jurisdiction of your police station.
2. The store deals in various merchandise including groceries, fruits, beverages, garments, beauty products, electronic goods, and other daily-use items.
3. On 03/10/2025, during an inventory audit conducted at the store, a **shortage of stock valued at Rs. 6,39,783/-** was detected. Based on an internal inquiry, two of our employees were found to be involved in the said theft. Their details are mentioned below. However, further investigation may reveal the involvement of additional employees or external persons.

#### Suspects:

1. **Arujit Gill**, S/o **Indrajit Gill**, residing at **Kharagpur Singh Road, Bairatisal, Solkanina, West Bengal - 734013**.
2. **Binay Balmiki**, S/o **Sherulal Balmiki**, residing at **Station Road, Masjid Para, Badgora, West Bengal - 734014**.

#### Details of the July 2025 Theft Incident:

On 30th July 2025, **CSA Arujit Gill** was apprehended internally while attempting to move unbilled merchandise valued at **Rs. 5,999/-**. During internal inquiry, he admitted to committing theft in collusion with ex-employee **Binay Balmiki**. It was also revealed that **Binay's father**, who is currently employed at the store as a housekeeping staff, was aware of

the matter. **Binay** was called to the store for questioning and he too admitted his involvement in the theft.
