Subject: Complaint against Physical Assault

Respected Sir,

I, Regula Vadakkeykandy, resident of Primia G, Palava Phase 2, Lake Shore Green, Thane Maharashtra came to my residence at Flat NO D4, Block C, Siliguri, Near Manokamna Flona Mill Sankalp Society, Siliguri on 3rd October 2025.

On 4th October 2025, at around 12:35, I was at the ground floor of the building. At around 12:40pm, my brother-in-law, Mithilesh Kumar alias Raju (Age 48), Son of B.P Singh (retired district judge), residing at Victor Colony near IMA Hall, Pune physically assaulted me by slapping me telling that the flat I own belong to him and claimed that he has an extra key and will take all the things from the flat.

Due to this assault, I sustained a bleeding injury and immediately went to the Government Hospital in Siliguri, where I received medical treatment.

He is harassing me with the intention of taking over property and assets. He has a servant's quarter in the same housing society, which makes me feel unsafe.

I therefore request you to kindly register my complaint against Mithilesh Kumar alias Raju, take strict action under the law for the assault and harassment & provide me with protection for my safety.
