I Mrs. Tharna Goswami, wife of
Mr Alok Kumar Goswami residing at Raidang
hereby lodge this complaint regarding a hit and
run accident that occurred on 14th September 2025
at approximately 6 P.M. near Raidang bazar.
On the forementioned date and time, The victim
Mr Alok Kumar Goswami aged 65 years was
walking on the footpath / side of road when a
Two wheeler vehicle bearing Reg No:- WB 74 A 9
8503, driving at high speed and recklessly
suddenly hit the victim.

As a result of the impact
Mr Goswami sustained severe injuries including
brain haemorrhage and was rushed to hospital where
The doctors declared the condition as critical. The
victim is undergoing critical care at hospital.

As the victim was hospitalised and in critical
condition, hence I could not file the complaint
earlier and was busy with attending the victim in
hospital
