Subject : Complaint against Omi Jaiswal for assaulting, threatening and ~~attempting to kill~~ *me*

Respected Sir,

This is to hereby bring in your esteem knowledge that I Advocate Raghav Agarwal, Son of Shri Pulok Kumar Agarwal, Residence of Punjabi Para, Shiv Mandir Road, Siliguri, would like to state that on 12th May 2025 my brother said Murari Agarwal got solemnised in Siliguri Uttar Banga Palace. Where I had hired Omi Jaiswal as a camera person for sum of rupees 41000/- as per terms and conditions. His work was incomplete so we asked him to complete the work and hand it over to us despite the amount of rupees 41000/- was paid. He further asked us to pay an extra amount of sum of rupees 5000/- for which we asked him to complete the work, he handed over the file on 11th September which was incomplete and despite of asking him to complete the work, he kept pushing for rupees to be paid.

On the event he visited the shop (namely Gita Fabrics) situated at Unity Building, sevole Road Siliguri, where he along with his female friend came at shop around 5-5:30 PM again asking for money. He was constantly shouting at shop, threatening and using abusive language to Mr. Pulok Kumar Agarwal.

On request of Mr. Pulok Kumar Agarwal I appeared at the spot where he was opening abusing myself and Mr. Pulok Kumar Agarwal, along with my brother and Mr. Rameshyam Agarwal (Super senior citizen). The abuse got turned into fight post which Panitanki Outpost was informed and Police arrived.

He (Omi Jaiswal) in front of everyone abused, threatened and attempted to kill myself where I have got marks on my left neck.

I request office on duty to take my complaint and proceed with all the necessary actions as per.

Also, I hereby notify Omi Jaiswal and his family will be solely responsible for any harm caused to me or my family in future.
