Based on the following observations, we have identified direct involvement of Md. Mustafa for this theft, his body language and behaviour in the footage. When I showed this footage to the store team, they said the body language looks like Mustafa. The individual's walking style, hairstyle (viewed from the back), and overall body language appear consistent with Mustafa's.

We have also suspect on below team:

- The shutter key, under Mr. Ashish Oraon's custody, observed that the safe key was left outside, constituting a breach of the store's safety and security procedures."
- Mr. Mukesh Singh, Store Manager aware that key kept on generator area as a store manager he should not allow his manager to keep key outside. This incident was happened in the morning 5:30 AM and store manager has informed about this issue to City head after 14 Hrs (8:00 PM)

Therefore, I respectfully request you to Register this complaint under the appropriate legal provisions and take necessary legal action as per the law.

Subject: Report of Theft – Rs. 98,309 from Bagajatin Wow Eats, Siliguri Bagajatin Road, Opposite Bagajatin Park

Respected Sir

I, Ajit Sharma, S/O Ram Prasad Sharma resident of Salbari Sukna, Dist Darjeeling Working as City Head at Wow Momo Foods Pvt. Ltd. I am writing to report a theft incident that took place at our outlet Bagajatin Wow Eats, located on Bagajatin Road, opposite Bagajatin Park, Siliguri in the morning of 3rd October 2025 5:30 AM. Approximately 8:00 PM, I received a phone call from the Store Manager, Mr. Mukesh Singh, informing me that a sum of Rs. 98,309 was found missing from the store's safe. Upon receiving the information, I immediately informed my reporting manager, Mr. Subrata Chakraborty, and rushed to the store. On arrival, I found Mr. Nityanand, our Store Auditor, already present at the premises. We conducted a preliminary internal inquiry and reviewed the CCTV footage, which revealed the following:

- An unidentified individual wearing blue jeans, a black jacket, and a Wow Momo t-shirt, and carrying a helmet, was seen approaching the premises at 5:34 AM
- The individual was observed rotating the external CCTV camera away from the entrance and then switching off the main power supply from the outside.
- Subsequently, the person unlocked the shutter using a key, entered the store, accessed the cash counter, and took money from the safe.
- After the theft, the individual left the premises and fled in a red Toto vehicle.

During internal questioning, Night Manager Mr. Ashish Oraon stated that the shutter key is typically kept inside the generator, a fact known to all internal store staff. This raises concerns regarding possible internal involvement.
