In producing herewith (i) Md Ashique @ Pappu (27 yrs) S/O Late Md Mustakim of Ashraf Nagar, Anchal bazaar, Ward No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (Not Verified) and (ii) Md Atirul @ Rahul (24 yrs) S/O late Md Badiya of Ashraf Nagar, Anchal bazaar, Ward No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (Not verified) along with the following seized articles viz.

- a) One transparent Zipper Plastic Pouch containing Total 381 grams approx with black colour plastic carry bag suspected to be Brown Sugar which was kept concealed in a white & Ash colour printed cloth carry bag was hanging in a bicycle handle seized from the exclusive joint and conscious possession of (i) Md Ashique @ Pappu (27 yrs) S/O Late Md Mustakim of Ashraf Nagar, Anchal bazaar, Wartd No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (Not Verified) and (ii) Md Atirul @ Rahul (24 yrs) S/O late Md Badiya of Ashraf Nagar, Anchal bazaar, Ward No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (Not verified) and marked as 'Exhibit- A'
 - b) One Old Black colour Hero Bi-cycle and marked as 'Exhibit- B'
 - c) Cash Rs. 5260/- recovered from the possession of Md Ashique @ Pappu (27 yrs) S/O Late Md Mustakim of Ashraf Nagar, Anchal bazaar, Wartd No. 40, PS- Bhaktinagar, Dist-Jalpaiguri (Not Verified) (Denomination :- Rs.500x10= Rs 5000/- and Rs.10x26= Rs 260) marked as 'Exhibit C'
 - d) One Green colour One Plus Android Mobile Phone having IMEI No.865952068946710 & 865952068946702 recovered from the possession of Md Ashique @ Pappu marked as 'Exhibit D'
 - e) One steel colour Redmi 5G Android, Mobile phone having IMEI 1:861831063009969 & 861831063009977 recovered from the possession of Md Ashique @ Pappu, marked as Exhibit- E,
 - f) One Deep blue colour Samsung mebile phone having IMEI 1:359960575176240/01 & 359950135176249/01 recovered from the possession of Md Atirul @ Rahul, Marked as Exhibits-F,
 - g) One white & Ash colour printed cloth carry bag, marked as Exhibits- G

[Articles noted in Sl. No. (a) was found in a handle of old black colour Bi-Cycle which was riding by Md Ashique @ Pappu and Md Atirul @ rahul was in sitting position on back side carrier of the by-cycle and SL No.(a) was recovered from the exclusive joint and conscious possession of (i) Md Ashique @ Pappu (27 yrs) S/O Late Md Mustakim of Ashraf Nagar,

Anchal bazaar, Wartd No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (Not Verified) and (ii) Md Atirul @ Rahul (24 yrs) S/O late Md Badiya of Ashraf Nagar, Anchal bazaar, Ward No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (Not verified)]

I, SI Prakash Ch. Sarkar of Siliguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted 02 (two) arrested accused persons namely i) Md Ashique @ Pappu (27 yrs) S/O Late Md Mustakim of Ashraf Nagar, Anchal bazaar, Ward No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (Not Verified) and (ii) Md Atirul @ Rahul (24 yrs) S/O late Md Badiya of Ashraf Nagar, Anchal bazaar, Ward No. 40, PS- Bhaktinagar, Dist-Jalpaiguri (Not verified) to the effect that today i.e on 08.10.2025 at about 22.15 hrs received a specific source information that 02 (two) persons were coming from Biswas Colony under Matigara PS and proceeded towards Jyotinagar near Jhankar more under Siliguri PS with by-cycle possessing huge quantity of narcotic substances Brown Sugar to sell the same to their designed customers. The matter was diarized in Siliguri PS General Diary vide Siliguri PS GDE No. 401 Dated- 08.10.2025 and subsequently, I informed the matter to the Inspectorin-Charge, Siliguri Police Station in written and being directed, myself along with ASI Sanktinath Dey, ASI Minhaj Al Kader, ASI Rabin Lama, ASI Debasish Das, C/1424 Ashok Barman, C/160 Soumen Sarkar all of Siliguri PS, SPC and along with investigation kit left for near Thakkar Bridge, Ward No. 04 under Siliguri PS by Govt. aided vehicle having Registration No-WB24K/7669, driven by CD-1148 Sudipta Nandi to verify the veracity of the source information. This refers to Siliguri PS GDE No. 402 Dated- 08.10.2025 and M.C.C No- 1290 Date-08.10.2025. I also informed cameraman namely Pradip Kr. Paul (60 yrs) S/O Late Jogannath Paul of NJP, Bhaktinagar, PS- NJP, Dist- Jalpaiguri (9832049445). Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender.

On the way to Jyotinagar near Thakkar bridge under Siliguri Police Station, I contacted two persons namely 1) Raju Kr. Das (40 yrs) S/O Sri Kertick Das of Jyotinagar near Thakkar Bridge, Ward No. 04, PS- Siliguri, Dist- Darjeeling, 2) Uday Das (39 yrs) S/O Sudhir Das of Tikiapara, Ward No. 28, PS- Siliguri, Dist- Darjeeling and make them aware about the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with the independent witnesses & cameraman noted above reached at Jyotinagar near Thakkar bridge under Siliguri Police Station Dist.- Darjeeling a 22.20 hrs and started a Naka Checking. After a few minutes and being pointed by the source we found that two persons were coming from opposite side of Thakkar bridge and managed to apprehend two persons and On being asked they disclosed their identity as noted above and after detaining we found that one person was riding the said By-cycle namely Md Ashique @ Pappu and another namely Md Atirul @ Rahul was sitting on the back side of carrier of the by-cycle and One white & Ash colour printed cloth carry was hanging on the said handle of bi-cycle. Thereafter, we disclosed our identity and informed them regarding the information in hand and stated them that they will be searched in person for the said purpose.

The above noted apprehended two persons admitted that they have illegally possessed Brown Sugar without any valid license for selling the same to their designed customers as per their requirement. I then gave them option in writing whether they wanted to be

searched in presence of an Executive Magistrate or by any Gazzetted Officer and they agreed to be searched in presence of any one of the above. As the time was odd and also time period of doing all required process is already overcharged. Hence, I informed the fact to Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station to act as a Gazetted Officer regarding interception of the accused persons suspected to be possessed illegal Brown Sugar and requested him to come at Jyotinagar near Jhakkar bridge under Siliguri PS to remain present and to supervise the search and seizure. Accordingly, Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer arrived at the spot i.e. near Jhakkar bridge under Siliguri PS as Gazetted Officer. Then, I offered the independent witnesses and the accused persons to search our police party as per provision of law but they did not search the police party but as per instruction of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer personal search of our raiding party and our vehicles was conducted but nothing incriminating was found. A nil search list to that effect was prepared. Thereafter in presence Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station (Gazetted Officer) and 02 (two) independent witnesses, I searched the detained persons namely (i) Md Ashique @ Pappu (27 yrs) S/O Late Md Mustakim of Ashraf Nagar, Anchal bazaar, Ward No. 40, PS- Bhaktinagar, Dist-Jalpaiguri (Not Verified) and (ii) Md Atirul @ Rahul (24 yrs) S/O late Md Badiya of Ashraf Nagar, Anchal bazaar, Ward No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (Not verified) following all formalities, keeping their decency and recovered a) One transparent Zipper Plastic Pouch containing Total - 387 grams approx with black colour plastic carry bag suspected to be Brown Sugar which was kept concealed in a white & Ash colour printed cloth carry bag was hanging in a bicycle handle - seized from the exclusive joint and conscious possession of (i) Md Ashique @ Pappu (27 yrs) S/O Late Md Mustakim of Ashraf Nagar, Anchal bazaar, Wartd No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (Not Verified) and (ii) Md Atirul @ Rahul (24 yrs) S/O late Md Badiya of Ashraf Nagar, Anchal bazaar, Ward No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (Not verified) and marked as 'Exhibit- A' b) One Old Black colour Hero Bi-cycle and marked as 'Exhibit- B' c) Cash Rs. 5260/- recovered from the possession of Md Ashique @ Pappu (27 yrs) S/O Late Md Mustakim of Ashraf Nagar, Anchal bazaar, Wartd No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (Not Verified) (Denomination :- Rs.500x10= Rs 5000/- and Rs.10x26= Rs 260) - marked as 'Exhibit - C' d) One Green colour One Plus Android Mobile Phone having IMEI No.865952068946710 & 865952068946702 recovered from the possession of Md Ashique @ Pappu - marked as ' Exhibit - D', e) One steel colour Redmi 5G Android Mobile phone having IMEI 1:861831063009969 & 861831063009977 recovered from the possession of Md Ashique @ Pappu, marked as Exhibit- E, f) One Deep blue colour Samsung mobile phone having IMEI 1:359960575176240/01 & 359950135176249/01 recovered from the possession of Md Atirul @ Rahul, Marked as Exhibits- F, g) One white & Ash colour printed cloth carry bag,

Further, on demand in presence of Shri Prasenjit Biswas, Inspector –in-charge, Siliguri Police Station acting as Gazetted Officer as well as independent witnesses the above noted detained persons failed to produce any valid documents in support of possessing of such contraband.

Being further interrogation, the accused persons noted above admitted in presence of Shri Prasenjit Biswas, Inspector –in-charge, Siliguri Police Station, acting as Gazetted Officer and the independent witnesses that they have procured the above noted illegal Brown Sugar clandestinely for the purpose of selling the same in high rate to their designed customers for

their personal gain by illegal means. They also disclosed that they have been dealing in this business of procuring and selling of Brown Sugar illegally for last few months for their wrongful gain.

Accordingly, I seized the above noted articles from the exclusive and conscious possession of the above noted accused persons at the spot at near Thakkar bridge under Siliguri Police Station Dist.- Darjeeling under proper seizure list in presence of Shri Prasenjit Biswas, Inspector –in-charge, Siliguri Police Station acting as Gazetted Officer as well as independent witnesses as noted above. Subsequently, I labelled the seized articles in presence of Shri Prasenjit Biswas, Inspector –in-charge, Siliguri Police Station acting as Gazetted Officer and independent witnesses as noted above. The whole process of seizure and label was made in between 23.05 hrs to 23.55 hrs on 08.10.2025. The whole process of Search seizure is under video graphed.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely (i) Md Ashique @ Pappu (27 yrs) S/O Late Md Mustakim of Ashraf Nagar, Anchal bazaar, Ward No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (Not Verified) and (ii) Md Atirul @ Rahul (24 yrs) S/O late Md Badiya of Ashraf Nagar, Anchal bazaar, Ward No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (Not verified) are involved in procuring and selling of Brown Sugar illegally contravening the norms of NDPS Act. Then, I arrested the above noted accused persons after observing all the formalities and informing the ground of their arrest and issued necessary Memo of arrest.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the accused persons namely (i) Md Ashique @ Pappu (27 yrs) S/O Late Md Mustakim of Ashraf Nagar, Anchal bazaar, Ward No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (Not Verified) and (ii) Md Atirul @ Rahul (24 yrs) S/O late Md Badiya of Ashraf Nagar, Anchal bazaar, Ward No. 40, PS- Bhaktinagar, Dist-Jalpaiguri (Not verified) and arrange for its investigation.
