Sir, we are shocked to see that our quarters (all the four flats) were robbed, wherein, the thieves broke open the main door of one of the ground floor flats and stole many articles (materials mentioned below) and then entered the other flats from the back side window by breaking the rod and wire mesh. Sir, this is further to inform that this is the 3rd time that theft had taken place in our quarters.

We humbly request you to kindly take serious actions against the culprits and recover the items stolen by them.
