Subject: FIR Against Swastik Trading & Co., Chowdhury Complex, Opp. Vega Circle Mall, Sevoke Road – Regarding Fraudulent Practices and Sale of Duplicate Products

Sir,

I am Smt. Arati Rani Mohanta, wife of Late Guru Gobinda Mohanta, residing at: Asian Highway-2, Opposite Aasta Hospital, Vill-Thiknikata, P.O. Sushruta Nagar, District-Darjeeling, West Bengal.

I am a senior citizen and a **cervical cancer patient**, also suffering from multiple health conditions including a fractured shoulder. I am under continuous medical supervision and undergoing treatment by various doctors. My late husband was a **state government employee**, and I currently receive a **pension** as his widow.

With the hope of improving my living conditions and mental well-being, I decided to initiate an interior renovation project at the residence of a close well-wisher. I invested over ₹8,00,000 (Rupees Eight Lakhs) into this work. The interior contractor, Mr. Dipankar Mallick, a trusted well-wisher, was supervising the project. Unfortunately, due to his personal health issues, he had to be hospitalized at Maharaja Agrasen Hospital, and during his absence, the work could not be properly monitored.

During this time, I was approached by employees of Swastik Trading & Co., who claimed to be the official outlet (direct selling office) of a reputed plywood manufacturing company. On the basis of their strong assurances and the belief that they were a trustworthy supplier, I purchased a large quantity of what was claimed to be ISI-marked 710 Grade Plywood (approx. 44–45 kg per sheet, 8'x4', full core, full panel, termite-proof, waterproof). I made payments totaling ₹4,00,000 (Rupees Four Lakhs) through a combination of cash and online (NEFT) transfers. However, as per their "company policy", they issued invoices for only a small portion of the actual transaction value.

In addition to the plywood, I also bore expenses amounting to another ₹4,00,000, including carpentry charges, labor, laminates (interior and exterior), adhesives (Fevicol), hardware accessories (hinges, channels, baskets, etc.). The renovation work began on 4th August 2025 at the following site:

"ANANTAM", Pathar Ghata Road, Block-A, Flat-15, Matigara, District-Darjeeling.

After a month, when Mr. Dipankar Mallick recovered and visited the site, he immediately noticed the inferior quality of the plywood and raised the issue with the company. According to his conversation with company representatives, they initially agreed to replace

the defective plywood and cover the related expenses. This occurred during the first week of September 2025.

However, after further follow-up, I was shocked to learn that the company has now completely denied any responsibility and has refused to replace the materials or compensate for my financial loss.

I later came to know that Swastik Trading & Co. and its plywood supplier, Jhapa Veneer and Plywood Udhyog Pvt. Ltd. (located at Ward No. 15, Village Jyamirgadhi, Municipality Mechinagar, District Jhapa, State Nepal), are not authorized to manufacture or sell IS:710 graded plywood. Their license is valid only for IS:303 grade plywood. This means the plywood was falsely labeled and stamped as IS:710 to deceive customers and gain higher profits. In short, I have been a victim of fraud and misrepresentation.

As a senior citizen with severe health problems, limited income, and no technical knowledge about plywood or interior work, I placed my complete trust in these individuals, only to suffer mental distress and significant financial loss. The amount I invested was from my late husband's savings, and now it feels like all of it has gone to waste.

Therefore, I earnestly request you to kindly look into this matter at the earliest and take appropriate action against the offenders to ensure justice is served.
