Respected Sir,

With due respect, I Paritosh Saha, (M/58years) S/O Late Lankeshwar Saha, residing at Sukanta Nagar Autostand, Near Sanghati Club, East Vivekananda Pally, Siliguri, P.S- Bhakti Nagar, District: Jalpaiguri, having fruits and vegetables shop No. TH-218 22, Baba Lokenath Mandi, Champasari, Regulated Market, Siliguri. Like to lodge this complaint against (i) Mr. Santosh Gupta (ii) Sonu Gupta (iii) Kanchan Gupta all three residing at Pedung Bazar, for cheating me of an amount totaling Rs. 5,14,858/- (Five Lakh Fourteen Thousand Eight Hundred and Fifty Eight).

Since, 2020 I was doing business with above mentioned, they were customer of my aforesaid Shop and their transactions were rolling based on their purchase, but suddenly with an intention to deceive me he kept on purchasing the amount with unpaid bills and promised accordingly to pay in the next purchase and after repeated reminders and follow up continued paying with a lump sum amount and suddenly he and his brothers were not traceable and their contacts were not reachable. Gradually few months back they came to our shop and purchased some items and during payment he had again paid a lump sum amount and approached me with a fraudulent intention and falsely represented to be genuine that they will pay the bill next day. And their total unpaid due bill reached to an amount totaling Rs. 5, 14,858/- (Five Lakh Fourteen Thousand Eight Hundred and Fifty Eight). In the month of September his driver with PICK-UP (Mahindra) came to our Mandi and on asking for payment they left their vehicle PICK UP (Mahindra) Being No. WB73H1225 and eloped.

On 09.09.2025 at about 21:05 hrs Mr. Sonu Gupta and his friend came at my shop (Regulated Market) and after prolong discussion he give me Rs. 60,000/- (Sixty Thousand only. Later he said that I will pay the entire remaining amount and after that I will take back my vehicle which is mentioned above. I was agreeing with their wards and after some time they left from the shop. I despite several reminders and follow-ups via calls, but alleged persons has neither returned the money nor given any credible explanation nor taken back his vehicle. I have reason to believe that the alleged persons had no intention of fulfilling the promise and deliberately induced me into parting with my money under false pretenses.

Hence, I pray before your kind honor may kindly consider my requisition and take necessary action against above mentioned persons and initiate to recover the money and take the Pick-up (Vehicle Mahindra) under your custody and obliged.
