With due respect humble submission, I Anita Roy (F/34yrs) wife of Balram Roy resident of Diesel Colony near Biplab Sporting Club, ward no. 01, P.S Pradhan Nagar Dist. Darjeeling would like to inform you that since last one month's one boy namely Rahul Sah was harassing my son namely Bicky Roy for their personal issue. Rahul Sah physical assaulted to my son and threatened him with dire consequences, due to this all my son sustained injured and he was scared with them. Later both family members done one meeting in front of local people regarding matter, but during meeting period Rahul Sah said that "Abhi to meeting ho raha lakin Durga Puja ke waqt tumko marenge chahe kuch bhi ho" after that Rahul Sah left from meeting. By listing Rahul Sah words I was scared about my son.

On 02.10.2025 at about 02:30 hrs my son Bicky Roy and his friend Jayant Kamti were enjoying Durga Puja at Sanjay Math (ground), 02 No. Panchanai Colony. Suddenly, Rahul Sah, Ajay Khariya, Pritam Khariya and their associated (at about 15 persons) came Sanjay Math and without any reason attacked on Jayant Kamti and he fall in the ground. When Bicky saw this, he rushed to save Jayant Kamti, they were in group and they beaten Bicky Roy badly. Due to this both children were covered in blood. One had a nosebleed, the other a head bleed. Later Rahul Sah (culprit) said that I told you before on during meeting period that I will not leave you any how. Now I did what I said and on meeting and from today stay away otherwise it will be very harmful for both of you in future.

Now also Jayant Kamti is suffering from nosebleed and Bicky Roy from head pain and both children treatment is going. We all are afraid of Rahul Sah statement that in future any incident occurred or create any problem with both children. Due to treatment of both children we have delayed to submit a written complaint against them.

Hence, I pray before your kind honor may kindly consider my requisition and strict legal action should be taken against above mentioned persons and initiate to save both children from those persons and obliged.
