Subject: FIR regarding repeated incidents of theft in my premises

Respected Sir,

I, Mrs. Seema Saha, wife of Mr. Jayanta Saha, resident of Anukul Bhavan, Tinbatti More, Ward No. 32, SMC Area, Siliguri, beg to lodge this First Information Report regarding thefts that have taken place in our premises. On 09/09/2025, I had already lodged a complaint with your police station regarding the theft of the copper pipe of a newly installed air-conditioner and an iron ladder from our Banquet Hall premises. Although one person was apprehended at that time, another miscreant had managed to escape. Till date, we have not received any information from the police regarding whether the other accused has been arrested, whether the stolen articles have been recovered, or what stage the investigation has reached. Regretfully, on 03/10/2025 at around 6:50 PM, a similar incident occurred once again. Some miscreants entered our premises and committed theft. Officers from your police station visited the spot and collected certain items left behind by the culprits, namely a pair of Hawai slippers, a bag, and some broken pieces of pipe. I therefore request you to kindly: 1. Register this fresh incident as an FIR. 2. Conduct a thorough investigation into both the earlier and the present incidents. 3. Recover all the stolen articles. 4. Take appropriate legal action against the offenders. 5. Ensure proper vigilance so that such incidents do not recur in future. Please note that if these matters are not investigated properly, it will become very difficult for us to continue residing in this area in safety.
