I, Smt. Kiran Bhagat, W/o Sri Rajib Bhagat, D/o Bharat Bhagat, Permanent resident of Kabi Tirtha Sarani, lake Town, Ward no- 33, Siliguri, P.S.-NjP, District- Jalpaiguri-734007 presently residing at my parental house at Ganga Ngar, Road No- 2, Ward No- 5, Siliguri, P.S.-Siliguri, District-Darjeeling-734005 would like to inform you that on 02/03/2025 my marriage was solemnized with Sri Rajib Bhagat, S/o Late Sudama Bhagat, resident of Kabi Tirtha Sarani, lake Town, Ward no- 33, Siliguri, P.S.-Siliguri, District- Jalpaiguri-734007 according to Hindu rites and customs at my parental house at Ganga Ngar, Road No- 2, Ward No- 5, Siliguri, P.S.-Siliguri, District-Darjeeling-734005. At the time of marriage, my parents have given valuable gold ornaments and Silver ornaments, entire utensils, alongwith valuable clothings, watch and electronic items. After one month of my marriage, the said Sri Rajib Bhagat started to come at home at late night with drunken condition and without any authentic reason he used to abuse me in filthy languages and assault me. Not only that after two month of my marriage, the said Sri Rajib Bhagat along with his mother namely Basiya Bhagat, and his Sister Smt. Namita Bhagat, Dipali Bhagat, Anjali Bhagat and brother in law Binod Routh who is husband of Anjali Routh started to create pressure upon me for bring a sum of Rs. 50,000/- and a Bike from my parents and when I objected them, they became more aggressive and started torturing me physically and mentally by using different means. Not only that on several occasion, they confined me in dark room without meal. It is pertinent to mention here that the said Binod Routh always telling my mother in laws to continue physical torture upon me and if she files any case then he will give money as because he is a government employee, Their physical and mental torture became part of my life and day by day their torture increased. On 06-10-2025, at about 7am, my husband Rajib Bhagat, along with his mother namely Basiya Bhagat, his sister Namita Bhagat and his Sister In law (Bhabhi) namely Namita Bhagat w/o- Sanjit Bhagat without any authentic reasons started abusing me in filthy language and started assaulting me with fist and blow and drag me by pulling my hair and this all incident is happened in front of sanjit Bhagat, but Sanjit Bhagat

not come to save me not only that the said Namita Bhagat w/o- Sanjit Bhagat went to neighbor's house and called Rekha Bhagat s/o Unknown and putul Bhagat w/o- Rekha Bhagat and after reaching at my matrimonial house both of them also abuse me in filthy language and try to assault me and at lastly all the above named persons forcefully ousted me from my matrimonial house by threatening that if I try to enter into the house, they will kill me and no one can do anything against them. after the said incident I went to Siliguri District Hospital and taken medical treatment where doctor advise me to take proper rest and visit after 2 day.

So, requesting you to investigate the matter and take necessary legal actions against my husband namely Rajib Bhagat and in-laws namely Basiya Bhagat, Namita Bhagat, Dipali Thakur, Anjali Routh, Sanjit Bhagat, Namita Bhagat, Binod Routh and neighbor Rekha Bhagat@ Paresh Bhagat, putul Bhagat for the interest of justice.
