In this regard I beg to complain that today i,e 09.10.25 at 19.05 hrs received a secret source information that one Somnath Sarkar of Purbadhantala, Satellite Township under NJP PS have been storing and selling huge quantity of Fire-crackers at his house without having any license or other valid documents violating the provision of law, which may endanger of human life, likely to cause injury and may cause loss of public property of the area. This refers to D.D, SPC GDE No.52 dated 09.10.25. Accordingly, I informed the matter to ACP, D.D, SPC. As per his kind order, I accompanied with S.I Krishna Parja, SI Ganesh Roy, C-686 Arup Saha, C/670 Ratan Roy, and LC/1332 Jayanti Oraon, rushed at the house of Somnath Sarkar with govt. vehicle to work out the information. This refers to DD SPC GDE NO. 53 Dated 09.10.2025.

On reaching at Purbadhantala, Satellite Township, I contacted with my source and being guided and identified by the source, we entered into the house of Somnath Sarkar and on search the above mentioned seized articles (Fire crackers) were found stored in his house. On interrogation he disclosed his identity as noted above. Further, on demand he failed to produce any valid documents / license in support of the possession of such quantity of Fire crackers stored at his house. There is a reason to believe that Somnath Sarkar has stored the said consignment of fire crackers which are combustible in nature and endanger to human life and property at his house at Purbadhantala, Satellite Township illegally and violating Govt. Orders. Moreover, the above noted fire crackers were stored without any precautionary and safety measures and thus, violated the Order of Hon'ble High Court Calcutta. Accordingly, I seized the above noted fire crackers under proper seizure list duly signed by the witnesses and acknowledged by the accused person namely Somnath Sarkar under proper videography. The whole process of seizure was made between 20.05 hrs to 20.30 hrs. Subsequently, I arrested the above noted accused person namely Somnath Sarkar U/S 35 BNSS observing all the formalities and informing the ground of his arrest.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused person namely Somnath Sarkar(M/32), S/O- Sri Paritosh Sarkar of Purbadhantala, Satellite Township, PS- NJP, Dist- Jalpaiguri under proper section of law and arrange for its investigation.
