Matigara and OTHERS for Land Mafia Racket with encroachment of land without valid papers, cheating, criminal trespass, and criminal intimidation, by making duplicate documents of land papers and also manipulating the Office of B.L. & L.R.O. Matigara with that forged land papers.

Sir,

I, Uttam Prakash Sahu Son of Late Debendra Kumar Sahu of , do hereby submit this against one Sri Mangal Sharma Son of Deodhari Sharma of Varanasi Uttar Pradesh (Who is a fake person and Complainant of Matigara P.S. Case No.545/2025 Dated 21.08.2025) along with Shri Bimal Chandra Roy Son of Late Chhiramohan Roy of Chotto Dhukuria, Rajpori, Post Office New Chamta, Police Station Matigara District Darjeeling along with 3) MD JAHID , Son of Md. Jamaluddin of Khopalashi, Jali Busty, Jhaguri, PO New Chamta, Siliguri, 4) Md. Safiuddin Son of Md. Faijul, Mithuin Saibo, Suraj Saibo, Biplob Barman, Jogesh Roy, Shymal Roy and others.

That the brief fact of the case is that my father was the owner of piece or parcel of land measuring 1.33 acres in Mouza Panchkalguri, J.L. No. 59, Recorded In Khatian No. 43, appertaining in R.S. Plot Nos. 178, 186, 184, 195, and 191 Corresponding to L.R. Plot Nos. 681, 982, 691, 693 and 730. That many years the land was barren and empty in the year 2024 when I enquired in the Office Of B.L. & L.R.O. Matigara I came to know that my father's Khatian was deleted and one Mangal Sharma name was reflecting in the Plot Information of Plot Nos. 681,682,691,693 and 730 recorded in Khatian No. 2572. Upon investigation in the BLLRO Office I applied for the order sheet upon which the name of Mangal Sharma was mutated in place of father as I and my family knows that my father never sold that land to any person till he died. When I obtained the order sheet of Mutation from the Office of BLLRO I came to know that the mutation was done vide Deed No. 5309 of 1986 and mutation was done in 22.09.2017.

Sir, since I am a law abiding citizen I took the course of law and appealed U/Sec 54 of West Bengal Land reforms Act 1956 in the Office of Ld. District Land and Land reforms Office Darjeeling vide Appeal Case No. 08/2024 Dated 22.05.2024. in such case it was came to be known that the Deed which was presented in the Office in the year 2017 to delete my fathers name was entirely fake as the actual Deed Being Deed Bo. 5309/1986 describes about some other land in Mouza Nirmal, J.L.No. 73, Block Phasidewa.

Sir, it is very pertinent to mention here that even after the deletion of such Khatian being Khatian NO. 2572 said Bimal Roy claimed the land and also posted videos every time he threatened me of dire consequences claiming

he have people in Panchayat Samity in future if I go to police I have to suffer inseparable loss

Sir, after some day when Bimal Roy cannot do anything to grab my land upon his instruction fake Mangal Sharma filed a complaint against me and other persons in your Police Station and also a case was registered being P.S. Case no 545/2025 Dated 21.08.2025 U/Sections 318(4)/336(3)/336(2)/340(2)/3(5) just to harass me without any preliminary investigation but just in the allegation of said Mangal Sharma and fake Deed Being No. 5309/1986 submitted by said fake Mangal Sharma just to manipulate even your good office .

Sir, the racket follows like this said Bimal Roy acts as a financier who funds the whole racket for making fake deeds, Khatians, Mangal Sharma is a person who makes false identity and represents himself as the owner of land, with MD JAHID Md. Safijuddin, Mithuin Saibo, Suraj Saibo, and Biplob Barman are all muscle man who threatens the real owners of the land to sell the land to Bimal Roy or face the dire consequences and when the owner disagrees they file false cases with false documents.

Sir today at around 11 AM I went to the said land along with my brother and suddenly Bimal Roy and the persons abovenmaed come to the said land and started abusing us started attacking us with bamboos, iron rods and also tried to snatch my mobile when I was making the video, Md. Jahid came with iron rod and tried to hit in my head but with the help of my brother I was saved but sir if I got hit with an iron rod in my head I would have died in spot and anyhow we ran away from our own land just because they have muscle power

and infact we have legal papers of land we cannot do anything so now it is your duty to provide us justice by arresting them.

Sir, I therefore request you to Register this and take this matter in serious concern as said Bimal Roy, Mangal Sharma forged Sale Deeds and Manipulate the offices and Police Stations just to harass the original land owners and they team up other persons as mentioned above as muscle power creating law and order problems and also influencing their power over the common man and law abiding citizens like me by filing false cases. Sir, if you don't take any action against such Bimal Roy and others in near future they will not be afraid of doing any criminal activities and their criminal intention will thrive more which I fear can make such persons commit more serious crimes.
