Sir,

I, Apurnamoy Ghosh, son of Late Dhairya Sadhan Ghosh, Principal Incharge of Banimandir Railway H.S. School, Siliguri Jn would like to inform you that on 07.10.2025 at 10.00 hrs I received an information from Ramesh Sarkar, Mali of our school that one incident of theft occurred in our School. After receiving such information along with other teachers & staff of the school namely Goutam Kumar Paul, TGT, Anamika Kumari Shah, Clerk, Laxmi Routh Modak, S/Cleaner, Kalyan Debnath, TGT & Ajit Sing Sardar PRT, I rushed to school and found the main door of Principal's Chamber was broken *& one DVR & one NVR of CCTV have been stolen.* After searching we found that on the night of 06/07-10-2025 unknown miscreant entered into principal's chamber and had broken two almirahs and stolen cash about Rs.30000- 35000/- and keys of different offices and some documents.

I would like to inform you that on the same day night one night guard named Bappa Patra was engaged who did the night guard duty during that period.

Presently, the Principal Madam of this school is not available and I will submit the details of missing documents after arrival of the Principal.
