It is to inform you that I, **Debraj Das**, S/O- Kartik Ch Das, DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby lodge a complaint against ANNA CHETTRI (USER), W/O- REAGAN LEPCHA, Address- Pokhajote, opp Blooming Dales School, P.S Pradhannagar, Dist-Darjeeling, Pin-734003 for *using a domestic meter for commercial purpose (running a school)*.

Today i.e, on 09.10.2025 (13.00 hrs), I came to Blooming Dales School, Pokhajote, P.S Pradhannagar, Dist-Darjeeling; in my officially hired vehicle for a routine inspection. I was accompanied by (i) Bhaben Roy, SO(S&LP), Darjeeling Region (ii) Rabi Sankar Singh, OE, Pradhannagar CCC & other technical staffs of Pradhannagar CCC.

On inspection of the premises (after observing all formalities), I found that the meter **L1687691** (Consumer Name- HELEN CHETTRI, Domestic Urban Category, Con Id-402564837) is being used for COMMERCIAL purpose.

I disconnected the connection of ANNA CHETTRI (USER) & seized the meter **L1687691**, after preparing the seizure list duly signed by the witnesses. Local people were present but none appeared.

Seized Articles:

- 1 phase energy meter **L1687691**, 240V, 5-30A, Make- Landys Gr (L/R-29787 KWH)

ANNA CHETTRI (USER) was present at the premises & received the Notice, Inspection Sheet & Seizure list. As such, ANNA CHETTRI (USER), has used a domestic meter for commercial purposes illegally and unauthorizedly and is liable for prosecution U/S 135 1(e) of Electricity Act 2003. Hence, you are requested to treat this as FIR.
