In this regard 1 beg to complain that today i.e on 11.10.25 at 17.15 hrs received a secret source information that one Subir Saha (M/45) S/O Narayan Ch. Saha of 13 Jibanananda Das Sarani, Rabindra Nagar, Rabindra Sarani, Ward No. 21. PS- Siliguri, Dist- Darjeeling have been storing and selling different types of banned Fire-crackers at his house without having any license or other valid documents violating the provision of law, which may endanger of human life, likely to cause injury and may cause loss of public property of the area. This refers to D.D.SPC GDE No. 63 dated 11.10.25. Accordingly, I informed the matter to ACP.DD.SPC. As per order, I accompanied with SI Basudeb Guha, Const. 670 Ratan Roy, Const 685 Arup Saha, Const 562 Utpal Saha and LC- 1310 Dipika Thapa all of DD, SPC, Siliguri rushed to the spot to work out the information vide D.D.SPC GDE No. 64 dated 11.10.25. I also took investigating kits/materials with me. On Subir Saha.

Then I conducted raid in the house of said Subir Saha and on being search I recovered "93 bundle of Black Cat Chocolate Bomb, each bundle containing 05 packets (93 X 5 = 465 Packets) total weight 48 kg 825 grams. Market Value approx Rs. 46,500/- from his house. On demand he could not produce any documents/licenses in support of the possession of such quantity of Fire Crackers. On question he confessed persons for his wrongful gain. It is pertinent to mention here that the house of above noted accused is situated in highly densely populated area. The accused was storing such banned fire crackers at his house order of Hon'ble High Court Calcutta. If any accident took place due to negligent act of the accused person that may cause loss of life and property of the area. The Fire crackers were stored without any precautionary and and duly signed by the witnesses and accused person. The seizure procedure was done in between 18.35 hrs and 19.15 hrs. Then I arrested the above noted accused person U/S 35 BNSS.

Under the above circumstances, I pray before your kind honour that a specific case may kindly be started against the above noted arrested accused person namely Subir Saha (M/45) S/O Narayan Ch.
