Respected Sir,

With due respect, I, SRI SARWAN PASWAN, S/O Ram Das Paswan, Resident of Subhas Pally, Bagrakote, P.S- Siliguri, Dist- Darjeeling, would like to inform you that SMT. RADHA PASWAN, D/O Sukhlal Paswan, Resident of Nimbu Basti, Pramod Nagar, Salugara, Ward No. 42, Sevoke Road, P.S- Bhaktinagar is my legally married wife and our marriage was solemnized on 24.04.2024 according to Hindu Rites and Customs from the parental house of my wife at Nimbu Basti, Pramod Nagar, Salugara, Ward No. 42, Sevoke Road, P.S- Bhaktinagar. Sir, after the aforesaid marriage, I, along with my wife, have started to live and cohabited together as husband and wife at my grandfather's aforesaid address and alongside me and wife, my old aged ailing grandparents and my other family members used to stay and live with us in the same house.

Sir, my wife used to verbally abuse me with filthy and derogatory languages and I have made my full and best efforts to understand my wife but she never used to understand me and on the contrary, she inflicted immense physical and mental torture upon me and moreover, she used to abuse me using filthy and offensive language, and also regularly insulted and humiliated me in front of others and despite all these humiliation and torture both mental and physical at the hands of my wife, I chose not to raise any protest, keeping in mind the sanctity and future of my conjugal life and I had hoped that, with time, she would definitely realise her own mistakes and rectify herself but however, all my hopes were gone in vain.

Sir, since the days of the inception my marriage, my wife has been threatening me to act according to her wishes and commands and moreover, she repeatedly stated that if I failed to comply with her demands, she would leave her matrimonial home and falsely implicate me and my family members in a false and fabricated Criminal Case and on 15.08.2025, my wife, on her own sweet will, without even informing me or any of my family members, left her matrimonial home and thereafter, on several occasions, I made sincere efforts to bring her back to her matrimonial home but however, she flatly refused to return and instead, my wife abused me with filthy and slang language and even drove me away from her parental house.

Sir, after returning to her parental home, my wife, in active collusion and conspiracy with her family members, lodged a false and frivolous complaint before the Siliguri Women Police Station and on the basis of the said complaint, one specific case being Siliguri Women P.S. Case No. 93 of 2025, under Sections 85 and 351(2) of the B.N.S, read with Section 4 of the Dowry Prohibition Act, was registered against

me and my family members and pursuant to the said case, Notice under Section 35(3) of the B.N.S.S. 2023 was served upon us, and thereafter, I along with my family members, duly surrendered before the Ld. A.C.J.M., at Siliguri, and were granted bail and presently I and my family members are on court bail in connection with the said case.

Sir, since after we were granted bail by the Ld. A.C.J.M Court, at Siliguri, my wife, in connivance with her family members, started to threaten me with dire consequences over the phone and I also came to learn from the local people of our locality that my wife and her family members have been openly issuing threats to kill me and end my life permanently. Sir, I have been running a small shop dealing in mobile accessories and LCD screens, situated at Rishi Aurobindo Road, Siliguri, under Ward No. 12 of the Siliguri Municipal Corporation and even at my said place of business, my wife namely Radha Paswan, her father namely Sukhlal Paswan, her mother namely Smt. Tara Devi Paswan, her brothers namely Lallan, Dilip and Suraj Paswan along with Rajib Paswan, Anita Paswan and others have on several occasions come to my shop and intimidated and threatened me with threats of dire consequences.

Sir, on 10.10.2025 at around 08.00 P.M., while I was at Ghosh Building for the purpose of procuring materials at wholesale rates, my father-in-law, Sri Sukhlal Paswan, my Mother-in-Law, Smt. Tara Devi Paswan, along with my Brothers-in-Law, namely Lallan Paswan and Suraj Paswan, and several other goons and miscreants under their leadership, came to the said place and physically assaulted me with fists and blows and moreover, they wrongfully confined me there and continued to assault me as a result of which, I have received injuries on my chest and head and during the said incident, they also broke the wristwatch which I was wearing, into pieces and also forcibly snatched away my Silver Chain and on hearing my cries for help, some local people gathered at the spot and rescued me from their clutches and thereafter, they fled away from the spot.

I, therefore, request you to investigate into the matter and please take appropriate strong legal action against my wife namely Radha Paswan, Father-in-Law, namely Sukhlal Paswan, Mother-in-Law namely Smt. Tara Devi Paswan, Brothers-in-Law namely Lallan, Dilip and Suraj Paswan along with Rajib Paswan, Anita Paswan and others, as per the provision of law and obliged thereby.
