I, Smt. Juni Subba, wife of Sri Bishal Chetry residing at Vill. Betgara P.O. Salugara, P.S. Bhaktinagar, District Jalpaiguri do hereby lodge a written complaint against my husband (1) Vishal Chetry, S/o Sri Saroj Chetry, (2) Smt. Sarita Rana, W/o Sri Saroj Chetry, (Mother- in-law), (3) Saroj Chetry (father-in-law), (4) Bicky Chetry S/o Sri Saroj Chetry (brother- in-law) (5) Nikita Chetry D/o Sri Saroj Chetry (Sister-in-law) and (6) Poyum Kongkang, all are presently resident at Bank Colony, Khonsa, P.O. & P.S. Khonsa, Dist. Tirap, in the State of Arunachal Pradesh and permanent resident of Vill. Sepoydhura Bazar, Chautaypani, P.O. Tindharia, P.S. Kurseong, District Darjeeling and I would like to inform you and begs to state as follows :-

1. That my marriage was solemnized with my husband Bishal Chetry, S/o Sri Saroj Chetry in the year 2014 as per Hindu rites and customs and we started living and cohabiting as a husband and wife at my matrimonial home at Vill. Sepoydhura Bazar, Chautaypani, P.O. Tindharia, P.S. Kurseong, District Darjeeling.
2. That out of the said wedlock I gave a female baby was born on 01/11/2016.
3. That after giving birth to a female baby my husband and my mother-in-law and others were not happy and they used to scold and abused me regularly since the birth of my baby most decent languages for giving birth to the female baby as they expected a male baby and they started abusing me in filthy languages and committing mental torture upon me frequently and thereafter

my in laws compelled me to leave the matrimonial home else to face dire consequences and I along with my husband and baby came to Betgara village within the jurisdiction of the Bhaktinagar Police Station and started living a rented house.

4. That even at the rented house at Betgara village my husband in an intoxicated with the instigation and incitement of my in-laws condition frequently used to commit torture upon me mentally and physically but I tolerated all these incidents for sake of my minor child and expecting peace conjugal life in future did not lodge any complaint against my husband and in-laws before any forum.
5. That my husband used to work as a Manager in ISUZU vehicle Show room, Hawrah Pump, Siliguri and used to frequently visit in the State of Arunachal Pradesh and he married one lady Poyum Kongkang above named of Arunachal Pradesh with aid and abetment of my in-laws and after marrying the said lady, he come in the first week of February 2022 and committed torture upon me mentally and physically at the incitement of my in-laws and the said lady and there after he went to Arunachal Pradesh and never came back.
6. That in spite of knowing that I am alive and has not been divorce and said lady and my in-laws aided and abetted my husband to marry her and the said lady knowing fully well that my husband is a married person having a minor child and his wife is still alive.

So, therefore, I humbly request you to take legal action against my husband and in-laws and the lady at an earliest.
