Sir,

I, Smt. Radharani Biswas, Daughter of Sri Dhiren Biswas, Aged about 25 years, Permanent Resident of Mehediganj, PO-Kamarvita, PS-Bhorer Alo, Dist.- Jalpaiguri, West Bengal-735135, would like to inform you that-

On the auspicious day of Bijaya Dashami, i.e., on 02/10/2025 at about 10:00 PM, while I was returning home to Mehediganj from my maternal uncle's house at Sahebpara, accompanied by my cousin brother Sri Shibu Sarkar, the accused person, Sri Biplab Bala, son of Sri Bohumullo Bala, resident of Sahebpara, under your police station, suddenly appeared near Gopegobijhora in front of us and began to severely misbehave with me in a filthy, obscene, and humiliating manner. He started abusing me with vulgar and indecent slangs, shouting – “*KHANKI MAGI JACCHE*”, and even made obscene insinuations questioning my relationship with my cousin by saying – “*SHIBUR SATHE JACCHE*”. When I protested, he forcibly touched me inappropriately, including my private body parts, dragged me by my hand, and tried to pull me towards a secluded area with an evident evil intention. When my cousin brother tried to intervene, he slapped him hard and shouted filthy abuses at him like “*SUORER BACCHA*”. Hearing our cries, some local people gathered, and somehow, we managed to escape that horrifying situation and reached home around 10:45 PM. I was terrified, humiliated, and deeply shaken. I narrated the entire incident to my mother that night, but as it was already too late, further steps could not be taken immediately.

The next morning, around 8:30 AM, my elder brother Sri Nikhil Biswas went to the house of the accused and informed Smt. Laxmi Bala, wife of Sri Bohumullo Bala and mother of the accused, about the entire obscene incident. Shockingly, instead of showing any concern or remorse, she replied dismissively, saying – “*Tomader ja khushi tai kore nao*”. Even then, considering the

family's social reputation and dignity, we decided not to escalate the matter and tried to move on.

However, last night i.e. on 08/10/2025 at about 11:00 PM, while I was standing near the front gate of my house, the same accused Biplab Bala once again came to me in an aggressive state. Without any provocation, he started hurling filthy, obscene abuses, shouting – "**KHANKI MAGI, RENDI MAGI AJ TOKE CHHARBO NA**" He then grabbed my hand forcefully, snatched away my scarf/dupatta, and touched me in a vulgar, indecent, and sexually abusive manner. He even tore the cloth near my shoulder and arm of my churidar, and threatened to rape me openly, saying he would "**not spare me tonight.**" I somehow managed to push him away and ran inside my house, trembling in shock, fear, and humiliation.

It is important to mention that this accused is a known habitual offender, previously booked and jailed in rape and murder cases, and his presence in the locality has created constant fear and insecurity among women.

Therefore, I earnestly request you to kindly take immediate and strict legal action against the said Sri Biplab Bala, investigate the matter thoroughly, and ensure his arrest under appropriate provisions of law for sexual assault, criminal intimidation, public obscenity, and rape threat.
