Sir,


I, the undersigned, on behalf of Bharat Petroleum Corporation Limited, New Jalpaiguri Top Loading Plant (BPCL NJP TOP), located at Bhaktinagar, District Jalpaiguri, wish to lodge this First Information Report regarding an incident of trespassing and theft that occurred within our premises on 3rd October 2025.

On the said date, from around 16:35 hours to 1700 hours, two unknown individuals were seen unlawfully entering our premises by climbing over the boundary wall. They were subsequently observed stealing petroleum product from one of our pipelines and collecting the same in plastic bags. The act appears deliberate and pre-planned.

This trespass and theft inside a petroleum installation is extremely serious. It not only violates law but also poses grave risk to life and property due to the flammable nature of petroleum products. Tampering with pipelines can lead to leakage, fire, or explosion, endangering our staff and the surrounding area. The incident is a direct breach of security and requires immediate police intervention.

In view of the above, I request you to kindly register this report under relevant sections of the Indian Penal Code for criminal trespass, theft, and mischief causing danger to life and property, and to initiate prompt investigation and necessary action. Enhanced patrolling around our premises is also requested to prevent recurrence.
