Respected Sir/Madam,

My Name is Suma Dandale, age 44 yrs (daughter of Ajit Kumar Routh, residing in Shivrampally, BBD Sarani, Haiderpara, Ward no-39, Siliguri) a citizen of Germany. I am presently in India due to the unfortunate demise of my mother on 21.09.25. I arrived in India on 22.09.25 to support my father & assist him in completing necessary documentation related to Reimbursements of money, LIC, Dr. visit, OP, RCT, and many others official matters.

During this difficult time, while I have been grieving the loss of my mother, I have been continuously harassed, abused and threatened by my brother 'Subrata Routh', who is currently residing & working in KOC - Kuwait Oil Company, Kuwait. He has been making abusive and threatening calls, stating that I will not be able to leave the country, and that he will file false complaints of Money Laundering against me. He has also threatened to block my travel and prevent me from leaving the country. Additionally, his wife 'Mrs Rekha Routh', (daughter of Mr. Ratan Malakar, residing in Khaprail, near army camp, Siliguri) sent residing in Kuwait sent a threatening message to my husband Dr. Phd. Rajesh Dandale (citizen of Germany) is a Renowned Cardiologist in Germany.

The threats and harassment include :

- Continuous use of abusive and intimidating language.
- Verbal threats to my safety and freedom of movement.
- Defamation financial matters.
- Attempts of forceful eviction & mental harassment.
- Psychological distress & emotional trauma during a period of mourning.

I am currently staying in India with my father and am feeling mentally and emotionally unsafe due to these repeated threats. I have 3 children in Germany, and this ongoing harassment has caused me severe anxiety & distress.

I, therefore, humbly request you to kindly register my complaint & take appropriate legal action against Mr. Subrata Routh & his wife Mrs. Rekha Routh, for harassment, intimidation & criminal threats, under the relevant sections of the Indian Penal Code. Please, acknowledge the receipt of this complaint & initiate an inquiry at the earliest. I am ready to provide copies of messages as required.
