I am Kanakya Mahato son of - Ram Sundar Mahato
residing at Champasari Anchal Dhaknikata ward no-46
I would like to lodge a formal complaint regarding
a violent incident that occurred on (13-10-25) at
10:15 Pm approx.

On yesterday, when my ^{daughter} sister go to left my Elder Aunt
to her home and after that she coming returned to
home on that time Songeeta Mahato, Suraj Mahato,
Bobita Mahato, Aditya Mahato, Bhola Mahato forcibly
dragged my ^{daughter} sister from the road into the house and
Physically assaulted her. When my ^{elder} brother tried to intervene
they attacked him and cause a serious head injury. The
incident took place at (Champasari Anchal Dhaknikata
at 10:15 Pm).

This act has caused great physical and mental, trauma
to my family. Therefore, I request you to kindly register
an FIR and take strict legal action, against the persons
responsible for the assault
