The Company became aware of the above-mentioned offences when it received summons in MACT Case No. **412/ 2024** from the Court of Hon'ble MACT, **Jalpaiguri, West Bengal**. The said Petition has been filed by **Krishna Mahato** on account of injury sustained by him in a road accident on **01-03-2022** involving offending vehicle bearing registration no. **WB-78-4799** which is a **Tata Sumo**. The said accident led to registration of FIR bearing no. **301/ 2022** dated **05.03.2022** registered U/s 279/ 338 of IPC at P.S.: **Matigara, Darjeeling, West Bengal**.

The vehicle bearing registration no. **WB-78-4799** as per the Petition stands insured vide policy bearing number **OG-22-2404-1803-00002548** and has validity till **09-06-2021 to 08-06-2022** and the vehicle is owned by **Munna Kumar Mahato**. S/o- **Jagnarayan Mahato**, residing at **Lake Town, Word No-46 of SMC, Siliguri, Dist. Darjeeling, West Bengal 734003**.

The Company in order to earnestly settle the claim undertook investigation and cross-checked the above-mentioned vehicle bearing registration no. **WB-78-4799** and policy bearing number **OG-22-2404-1803-00002548** against the data base of the Company. The Company was shocked to find that the Company has not issued any policy against the said vehicle which covers the date of accident and the policy number **OG-22-2404-1803-00002548** is an invalid policy and such never existed in our system. The offenders here have forged the policy document and used the company seal to create a document so as to claim compensation illegally from the company. If there is a policy that has been seized by the police, same is a forged and fabricated one.

In light of the above-said facts and circumstances it is prayed to initiate suitable action as no policy issued by the Company was in existence at the time of accident involving vehicle bearing registration no. **WB-78-4799**.

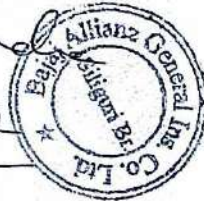
