With due respect and honour I Srimati Abda Khatun wife of Md. Reyaz Ansari & daughter of Md. Salam @ Hafiz Abdus Salam at present residing at Mamta Para P.O. Sahudangi Hat, P.S. New Jalpaiguri, District -Jalpaiguri would like to inform you the following facts and circumstances for your kind consideration and prompt legal action please.

That my marriage was solemnized on 13.06.2024 with Md. Reyaz Ansari son Md. Mustaque Ansari at present residing at Simultala near Bhanga Pool Matigara P.S. Matigara, District-Darjeeling as per Muslim Rites and custom in the house of my father at Mamta Para P.O. Sahudangi Hat, P.S. New Jalpaiguri, District-Jalpaiguri and registered on 14.06.2024 before the Muslim Marriage Registrar & Kazi Siliguri Sub-Division, District-Darjeeling.

That at the time of solemnization of my marriage my father presented gold ornaments weighing about 05 Bhari including Nose Ring. Earing, Finger rings, Chain, Necklace, and silver ornaments weighing about 50 Bhari including payel and chain. Besides this my father also presented a Almirah, Khat, Alna, Dressing Table, Colour T.V. Sofa set, one set utensils each of Brass, Silver & Bronze valued at Rs. 200000/- for the common use of mine and my husband as per the demand of my husband and his family members. More so the house hold articles like beddings clothing cosmetics goods and garments valued at Rs. 100000/- only were also presented by my father to my husband as streedhan for the common use of mine and my husband.

That after marriage I was taken by my husband to his house at village-Simultala near Bhanga Pool, Matigara P.S. Matigara, District-Darjeeling where I resumed my conjugal life with my husband. That on the next day of boubhat my Mother in-law took all my ornaments in her custody.

That during marriage ceremony my father had already been expended more than Rs. 8,00000.00 (Rs. Eight Lakhs) for every requirements of the said marriage. However immediately after 03 months of my marriage my husband and in-laws and near relatives of my husband started insisting me to go back to my parent's house to bring a dowry of Rs. 5,00000.00 (Rs. Five Lakhs) only as they were in extremely need of money for completing the construction work of their house. That when I expressed my inability to bring such amount of money from my parents my husband, mother in law, father in-law, brother in-law and wives of my brother -in-law started abusing me in filthy languages and also abused my parents in humiliating vulgar languages and due to my such inability to bring such amount of dowry from my parents the above named persons have tortured me physically and mentally continuously.

That however of change in mind of my in-laws and keeping in view of my own marriage future life, I had been tolerating their all such inhuman torture and cruelty and led a life of hell.

That in the third week of October 2024 my husband, mother in-law, father in-law, brother in-law and wives of brother in-law assaulted me physically, indiscriminately inhumanly with their fists and blows and closed me in a room without food and water and planned to kill me at night by pouring kerosene oil upon me for not fulfilling their demand of dowry, I screamed for help but nobody came for my rescue. That in the night of 17.10.2025 my husband assaulted me seriously and hit on my both ears with a iron screw Driver and damaged my ears. That I informed my parent that I was sick due to assault by my husband and his family members and neither my husband nor his family members took me to doctor for treatment nor provided me proper food and requirement of life. That on the next day my mother came and took me to Siliguri District Hospital where I have been treated by the Doctor.

That when my father learnt about the said torture upon me both physically and mentally by my husband and his inmates then he along with his well wishers came to my matrimonial home in the first week of November and tried to settle the dispute but my husband and his family members straight way told him -"either pay Rs. 500000.00 (Five Lakhs) as dowry or take back your daughter". My father and his well wishers tried their level best to solve the dispute but in vain. That my father told my husband that he had given him all as per his capacity and at present he is under huge amount of loan and requested them to stop physical and mental torture upon me but in vain.

That lastly on 06..06.2025, knowing me seven months pregnant my husband, mother in-law, father in-law, brother in-law and wives of brother in-law assaulted me with fist and blow and leg and keeping all my ornaments and belonging in their custody drove me out of my matrimonial house for not fulfilling their demand of dowry and finding no other alternative being compelled I returned to my parent's house at Mamta Para P.O. Sahudangi Hat, P.S. New Jalpaiguri, District - Jalpaiguri and since then I have been living with my parents as distressed, neglected and deprived. That my husband and his family members mentioned above threatened me with dire consequences if I dare to come back to my matrimonial house without dowry or to lodge any case against them.

That on 01.08.2025 I gave birth a male child namely Md. Shazaib at Mediview Clinic & Nurshing Home Siliguri . That my husband and his family members never came to see me nor contributed a single penny for my treatment at the time of my delivery. That I was in hope that my husband will come and take me to his house and I will live peacefully but in vain as such delay has been caused which may kindly be condoned.

That I lodge this complaint against my
