In producing herewith the 01 (One) arrested accused person Sadhan Adhikary (M/31) Inspector-In-Charge  
Girish Adhikary of Kanchanbari, PO- Fulbarihat, PS- NJP, Dist- Jalpaiguri along with the Inspector-In-Charge  
seized article under proper seizure list :-

- (i) One white and yellow color sack containing seems to be Ganja weighing 6.848 Kg marked as Exhibit-A.
- (ii) One black and red color pithu bag in which kept the Exhibit-A.
- (iii) One black color vivo Y56 mobile phone having sim no-9775738168, IMEI 1 No. 863595066174058 and IMEI 2 No. 863595066174041.
- (iv) One Adhar Card in the name of Sadhan Adhikary having Adhar no-568717950901.
- (v) Cash amounting Rs. 340/- (INR).

I, SI Sanjit Das of NBMC OP under Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint to the effect that on 14.10.2025 at about 20.05 hrs. I received a specific information provided by a credible source that 01 (one) male person carrying huge quantity of illegal Ganja (Cannabis) and will board a bus from Kawakhari Medical More under NBMC OP area and will proceeded towards Kolkata for its further disposal.

Hence, there was a strong reason to believe that there is every chance of committing a cognizable offence under NDPS Act and to check the veracity of information, I reduced the information in writing vide NBMC OP GDE No. 440, dated 14.10.2025 and I intimated the information to Shri Sajal Roy, O/C NBMC OP Under Matigara PS, SPC who brought the information to the superior and after obtaining necessary order at about 20.15 hrs myself, along with a team of NBMC OP Under Matigara PS, SPC consisting of ASI Krishnendu Roy, ASI ASI Bhanu Pradhan, C/1114 Avrojit Karmakar all of NBMC OP under Matigara PS, SPC took departure vide C.C. No- 1888/25 dated 14.10.25 from NBMC OP for Kawakhali Medical More with investigation kit by a Govt. vehicle to work out the information and the same was diarized vide NBMC OP GDE No. 441, dated 14.10.25.

At the same time I also informed the videographer namely Mithun Singha, S/O- Lt. Baldev Singha of Kawakhali, PO- Sushrutanagar, PS- Matigara, Dist- Darjeeling to be present at Kawakhari Medical More under NBMC OP area, PS- Matigara, SPC to prepare the Video of whole process of search and seizure if any.

On 14.10.25 at about 20.30 hrs, we reached Kawakhari Medical More and I met with my source and he briefed me about the detail information and stated that the suspected person would arrive anytime at Kawakhari Medical More for board a bus. Before that I looked up for public witnesses to the entire process of search and seizure and found two who were unwilling but later they gave their willingness to act as an independent witnesses. The particulars of the witnesses are as follows 1] Bapan Natta S/O- Late Jagadish Natta of Mini Market, Kawakhali Medical More, PO- Sushrutanagar, PS- Matigara, Dist-

Darjeeling and 2] Manotosh Barman S/O- Dhanesh Barman of Kawakhari Medical More, PO- Sushrutanagar, PS- Matigara, Dist- Darjeeling and I briefed them the information we had and requested them to stand as witness, who agreed to be stand as witness during the process of search and seizure and other process. After that we started waiting for the said person.

In the mean while, O/C NBMC OP told me over telephone that he has sent message to SDO, Siliguri to depute an Executive Magistrate during search & seizure of NDPS substances as per norms vide NBMC OP ORG No. 73/2025, Dated- 14.10.2025. But after telephonic conversation, it came to know that due to odd time and short notice, there is no Executive Magistrate available to perform the duty. In the above circumstances and the gravity of the information, if any delay occurred, the accused person may escape. Hence, as per order of superior, O/C NBMC OP Shri Sajal Roy in the rank of Inspector of Police left PS for the place of occurrence to supervise the search & seizure if any.

At about 22.00 hrs, my source identified the person standing at Kawakhari medical more for bus with a black and red color pithu bag on his back and we managed to apprehend him. At about 22.15 hrs Shri Sajal Roy, O/C NBMC OP in the rank of Inspector of Police, SPC arrived at the spot as a Gazzeted Officer where I briefed him the information in a nutshell. Also introduced the witnesses as noted above.

We then cordoned him and I introduced myself and the raid team members as Police officers. I appraised him about the information in hand and started to examine him thoroughly. On interrogation he disclosed his name and address as mentioned above. On interrogation the detained person confessed that there was huge quantity of Ganja (Cannabis) in his pithu bag which he was carrying from Coochbehar and was going to Kolkata for its clandestine disposal.

As per provisions of section 50 of the NDPS Act, 1985 (as amended) I explained the above noted detained person that he has legal right to tender his personal search in front of an Executive Magistrate or a gazette officer and the same was given to him in writing. In reply he wanted to be searched before any police officer.

On further interrogation, the detained person confessed in front of the Gazette officer Shri Sajal Roy, O/C NBMC OP in the rank of Inspector of Police that he was in conscious possession of huge quantity of Ganja (Cannabis) in his pithu bag. Thereafter, in presence of the Gazetted officer, and the two independent witnesses we searched the detained person and his pithu bag. During search we found One white and yellow color sack containing seems to be ganja in the black and red color pithu bag of the apprehended person and also found one mobile phone, one Adhar card and cash amounting 340/- (INR) in the possession of the person.

On interrogation, the detained person stated that he brought those ganja from Coochbehar to deliver to his designated customer at Kolkata and came at Medical More for catch a bus which will proceeded towards Kolkata. Then, I asked him to produce the valid license/ documents for carrying and possessing of the huge quantity of illegal narcotics contraband articles but he failed to produce any legal papers.

Thus, a reasonable belief having been formed that an offence has been committed in contravention of the NDPS Act and that recovered articles were liable to be confiscated NDPS Act. Accordingly, I had seized the above noted articles under proper seizure list duly prepared by me in presence of independent witnesses and Shri Sajal Roy, O/C NBMC OP in the rank of Inspector of Police, SPC who was acted as Gazetted officer.

Thereafter, one white and yellow color sack containing seems to be Ganja weighing 6.848 Kg have been seized, marked as Exhibit-A and labelled. I also seized One black and red color pithu bag in which kept the Exhibit-A, One black color vivo Y56 mobile phone having sim no-9775738168 IMEI 1 No. 863595066174058 and IMEI 2 No. 863595066174041 ; one adhar Card in the name of Sadhan Adhikary having Adhar no-568717950901 and Cash amounting Rs. 340/- (INR). I also took signature of the witnesses, accused person and Gazetted officer and put my signature as seizing officer. Considering the gravity of the offence and due to exceptional circumstances being unable to prior permission of the magistrate of the First Class, at this odd hour of night, I arrested the above noted accused person and issued arrest memo to him accordingly, duly signed by the accused person and witness. I also informed him the ground of arrest for the possession and carrying of contraband Narcotic drugs under the NDPS Act.

The entire process of Search, seizure, Label, Seal and arrest were done in between 22.20 hrs to 23.05 hrs. The entire process of detention, search, seizure sealed and labeled under the supervision of Shri Sajal Roy, O/C NBMC OP in the rank of Inspector of Police and video graphed of search and seizure conducted through the camera of Mithun Singha, S/O- Lt. Baldev Singha of Kawakhali, PO- Sushrutnagar, PS- Matiara, Dist- Darjeeling in compliance to the Order of Hon'ble High Court, Kolkata.

Under the above noted fact and circumstances you are requested to kindly lodge a FIR under proper section of law and arrange its investigation against accused person namely Sadhan Adhikary (M/31), S/O- Late Girish Adhikary of Kanchanbari, PO- Fulbari, PS- NJP, Dist- Jalpaiguri and others involved in this racket.
