SUB : FIR AGAINST DR. M. L. DHANDHANIA OF  
NORTH BENGAL NEURO CENTRE.

Sir,

my brother-in-law, Mr. Bhabesh Rai, aged 33 years has been admitted in North Bengal Neuro Centre since September 15<sup>th</sup>, 2025. He has a health insurance from Star Health and Allied Insurance Company Limited (Policy No - 1505112501092197). He is quite serious and has CVA - Right MCA Territory Infarct and Hypertension, Thrombosis. His right brain has 70% haemorrhage and his left body is paralyzed. When he was admitted in North Bengal Neuro Centre which is a cashless hospital listed under Star Health insurance, it was done under insurance. But again and again the hospital director demanded money from the patient's party and even threatened to discharge him. Today dated 14<sup>th</sup> Oct, 2025 when the Director, M. L. Dhandhanua demanded money from me, Sumendra Tamang, s/o Suway Tamang. I simply told him the cashless hospital scenario and if we have to pay money we will do it after he is discharged, after consultation with the insurance company. But Dr. M. L. Dhandhanua started verbally abusing me and physically assaulted me around 5.20 PM. This is a total break of

trust and such hooliganism cannot be tolerated. In such case scenarios, hospitals and insurance company have to solve the situation through proper communication but instead the Director of North Bengal Neuro Centre choose to physically and verbally assault me by calling me in his office.

I must confess here that I belong to a scheduled tribe community and Mr. Dhandhanua verbally abused me by saying "During admission time, you speak like a beggar and when it comes to payment, you don't pay". This is a direct insult on me and my ST background.

Therefore, I would like to lodge an FIR against Dr. Dhandhanua for verbally and physically assaulting me and causing verbal atrocity to a minority according to the rule of the land. And if my patient faces any threats of early discharge it will be against our will.
