Respected Sir,

With due respect and humble submission I, Dr.  
Manohar Lal Dhanadhamia, Director of North Bengal  
Neuro Centre Pvt. Ltd., Pradhan Nagar, Siliguri would  
like to inform you that one patient, Bhabesh Rai was  
admitted on 15.09.2025 with brain stroke and clot  
in brain, the course of treatment was going on and  
the patient is stable now and two operations were  
conducted. The brief fact is that total bill till  
date is Rs. 6,20,000/- (approx) and the Star Health  
insurance who is the insurance company of patient  
party have only approved Rs. 2,00,000/- till date and  
our accounts department have informed the same  
to the patient party and requested them to pay  
some amount as the due was 4,20,000/- which  
is little higher in aspect of due bill with an  
advisory, making them understand that if the  
insurance company approved the amount the  
account department or the hospital would refund  
the amount whatever will be approved by the

Star Insurance Company at the last or finally,  
today on 14/10/25 at around 17.00 hrs to 18.00 hrs  
when such things were going on may be one  
of the brother along with other persons related  
to patient partly started abusing and shouting  
near the accounts department and when I, asked  
them to come in my room and started explaining  
the same they became furious and abused me  
with filthy languages and started physical assault  
upon me and damaged my room very badly  
so I was very terrified and called my security  
by which they even physically assaulted him, when  
my receptionist being a lady came to stop them  
they also physically mishandled her body outraging  
her modesty and threatened me and my entire  
hospital that they will do something very bad  
in near future.

Therefore Sir, kindly take this complaint against  
the patient party of Bisabesh Rai and his family  
members for physical assault to doctor in his own  
hospital, harassing the hospital property and physical  
mishandling the lady receptionist and outraging  
her modesty. It is very sad to say that when  
we try so hard to save the patient - and even  
after giving such service people in spite of acknowledging  
the work in return treat us so violently.
