Sir,

With due respect, I Kanchuk Delma, wife of Karma Lotey, Chimuna PS, Phuntsholing Drukchag, Bhutan, would like to lay few lines of grievance for your kind action please. I saw the advertisement on facebook by Symmetric Clinic and contacted through whatsapp and got my appointment for eye lid surgery on 13th oct at 4pm. I and my friend Rinchen Selden, daughter of Dorji Rinchen, Chimuna PS, came to clinic at 4pm and at 5:30 my surgery began. When I went to surgery I kept my hand bag with her and she waited in sitting room. After the surgery I was kept in rest room with ice pack on my eyes and made to rest lying on bed. I called Rinchen in my room and she sat there with hand bags. After sometime, I sent her to counter to talk to staff for medical documents and she has left the hand bags in the room. Sushma a house keeping staff has earlier told us that there is CCTV everywhere and its safe. When Rinchen left the room she saw Sushma entering my room. After sometime when Rinchen did not return from the counter, I called her name by shouting, and there was no response. I didn't realise that Sushma was present there. Later when Rinchen

returned she saw sushma still in the room. I then
woke up to go to toilet and sushma showed me
the toilet which was inside that very room and she
left. After that we rested for a while and went to
counter to get medicine and do payment. When I
opened my hand bag I found out that my money
went missing. I reported the staffs in the counter
that my money is missing. One of the staff informed
the owner Dr. Amit Kr Chondhary and I was told that
the Dr. Amit said he can check the CCTV footage only
next morning and asked me to come at 11 AM next
morning. I called Dr. Amit at 8:39 pm after reaching
home and requested him to help me by checking
the CCTV footage the same day but he said he
was tired and will check next morning. When next
morning I went to meet Dr. Amit I was informed
that CCTV recording is not there. Since I am not
getting support and good response from the clinic
owner, I have no choice than to report to police.
The Dr. Amit also told me that he can't do
anything and police will look into the matter.
Therefore, I request your good office to
look into the matter and help me recover
my money lost which is Rs 5000 along with
purse.
