Sir,

In producing herewith one arrested accused person namely Ajeet Kumar (28 Yrs) S/O Vinod Rai of Vill+P.O.-Banauli, PS_Simri, Block-Singawara, Dist.-Darbhanga, Bihar presently residing and working at a shop named & style as "Saree Matching Center" situated at Seth Srilal Market, W/No. 11, PS-Siliguri, Dist.-Darjeeling under custody along with the following seized articles viz:-

(i) 15 (Fifteen) paper made cartons containing 960 pieces of portable gas lighter in each cartons, having total 14400 pieces of portable gas lighter which were stored negligently & dangerously in a commercial building named "Bholanath Building" situated at Hongkong Market opposite Chandni Garments shop, W/No. 11, PS-Siliguri, Dist.-Darjeeling.

I, ASI. Supriya Mandal of Panitanki TOP under Siliguri PS, SPC, do hereby lodge this written complaint against the above noted arrested accused person and others to the effect that on 14.10.25 at 19.15 hrs during my mobile van patrolling duty I have received information from a secret source that a huge quantity of portable gas lighter which are combustible in nature, illegally procured and stored dangerously in a commercial building named as "Bholanath Building" situated at Hongkong Market opposite Chandni Garments shop, W/No. 11, PS-Siliguri, Dist.-Darjeeling. Accordingly I conveyed it to O/C, Panitanki TOP and noted the same in general diary vide Panitanki TOP GDE No. 294 dt. 14.10.2025.

Subsequently, as per direction of O/C, PNT TOP myself along with ASI. Surojit Mallick, ASI. Amal Barman, ASI. Abhradip Das, ASI. Manmohan Barman, C/702 Latifur Rahaman, C/739 Dilip Mitra had been to the spot where we met with personnel of SOG, SPC led by SI. Rashbihari Saha, SI. Binod Kr. Jha & others. Later, being pointed out by the source, we have jointly conducted raid at a commercial named as "Bholanath Building" situated at Hongkong Market opposite Chandni Garments shop, W/No. 11, PS-Siliguri, Dist.-Darjeeling and found that huge quantity of portable gas lighter are stored in that building in a negligent manner which can lead into a fatal incident at the articles are combustibles in nature. Then we have apprehended the store keeper of this godown namely Ajeet Kumar who during interrogation do not able to produce any valid documents in respect of these articles and admitted that these combustible articles are procured illegally by his employer Ajoy Kumar and stored there negligently & dangerously for their wrongful gain. He also admitted that he has sufficient knowledge about its combustion nature but driven out of greed of huge money he does not disclose it to anyone. In the meanwhile we have managed to call two independent witness namely (i) Ajay Agarwal S/O A.K.Gupta of Bhanunagar, w/No. 42, PS-Bhaktinagar, Dist.-Jalpaiguri & (ii) Harish Sharma S/O Rajkumar Sharma of Hill Cart Road, Ganga Goli, Pan-pata Building, W/No.-06, PS-Siliguri, Dist.-Darjeeling and inform them about the fact/information in verbally. Subsequently, I have seized the above noted gas lighters under proper seizure list in

between 19.35 hrs and 19.44 hrs in presence of the said independent witnesses which is duly signed by the accused and endorsed by the witnesses. Then I have arrested him u/s 35(1) BNSS after explaining his ground of arrest and the charges against him to prevent him from committing further offence.

Hence, under the above noted circumstances, I request you that a specific case under proper sections of law may kindly be initiated against the above noted arrested person Ajeet Kumar (28 Yrs) S/O Vinod Rai of Vill+P.O.-Bnauli, PS-Simri, Block-Singawara, Dist.-Darbhanga, Bihar presently residing and working at a shop named & style as "Saree Matching Center" situated at Seth Srilal Market, W/No. 11, PS-Siliguri, Dist.-Darjeeling and his employer Ajoy Kumar for causing danger to human life & their negligent conduct with respect to combustible substance and arrange for its investigation.
