**SUB: WRITTEN COMPLAINT AGAINST THE DRIVER OF WAGON R. (VEHICLE BEARING
NO. WB/73/G/9644)**

Respected Sir,

With due respect and humble submission I Pratibha Tamang, Wife of Sri Madhukar Rai, resident of Dr. Grahams Homes, VTC Pudung Khasmahal, P.O. Pudung, District Kalimpong would like to inform you that today around 10.05 am my sister-in-law, Ruth Merry Lepcha who is a constable in Siliguri Police Commisionarate met with an accident near Army Track Marshal on NH27 where she sustained injuries and when she was taken to North Bengal Medical College and Hospital the doctor declared that she was brought dead. The brief facts of the complaint is as follows.

That she was detailed to report before O/C Bagdogra and after reporting there she was ordered to perform her law and order duty in Mela and Puja Immersion at Tarbandha Nabojiban Durga Puja Committee under Bagdogra Police Station. That when she was going towards her duty post in her scooty bearing No. WB-74-AU-7342 at around 10.05 am near Army Track Marshal on NH 27 one Wagon R bearing number WB/73/G/9644 driving very negligently with a very high speed in a rash and negligent way from the opposite side dashed the scooty in such a way that my sister sustained serious injuries and after such accident said driver of the vehicle inspite of taking her to hospital or informing any authority for help or her medical treatment left her with her injuries in the road and

fled away also leaving his vehicle in the accident spot and with the help of local people and police she was taken to NBMC where she was declared brought dead.

Therefore sir I write this complaint against the driver of the said vehicle as mentioned above and request you to kindly investigate the matter so that the culprit is punished according to law. My sister-in law who was going on the way to perform her duties for the public welfare was dashed in the road by the vehicle which was coming from the opposite direction in such high speed and negligent way by which we can understand that the intention of the driver was not good and further inspite of helping her to get medical treatment he fled away from the scene leaving my sister to die in the road.

Sir, I request you to kindly accept this written complaint therefore kindly take strict action against such person for rash and negligent driving in the road causing death of my sister-in-law and arrest him as soon as possible for the ends of justice. Thanking You.
