F.I.R. against (1) AMIT BHUIMALI, (2) BUDHAN BHUIMALI and (3) SMT. NIRMALA BHUIMALI, for physical assault

Respected Sir,

I, Smt. Chanda Malpahari, D/o. Sri Madan Malpahari, R/o. Hat Khola, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, INDIA, would like to state that (1) AMIT BHUIMALI, S/o. Budhan Bhuimali, (2) BUDHAN BHUIMALI and (3) SMT. NIRMALA BHUIMALI, W/o. Budhan Bhuimali, ALL R/o. Rabindra Nagar, Near Panchayat Office, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, INDIA, are anti socials of the locality and their main source of income is to set up gambling boards & sell liquor in the Hat Khola locality and earn money. Today i.e. on 07-10-2025 at about 5.15 P.M. when I & my brother Rama Malpahariya saw them setting the gambling board & was about to start the gambling, I & my brother protested then and there. When I & my brother started shouting Amit Bhuimali & Budhan Bhuilamli caught hold of me by my neck and physically assaulted me with hits and blows. Then and there my brother called my elder brother Sri Bikash Malpahari and when he tried to save me from their cruel hands Amit Bhuimali & Budhan Bhuilamli, suddenly another lady namely Smt. Nirmala Bhuimali came and started abusing my brother namely Bikash Malpahariya with kicks & blows. I & my brother are Scheduled Caste by Caste / Tribe and Amit Bhuimali, Budhan Bhuilamli and Smt. Nirmala Bhuimali threatened me by using slang language and said "Tu log tribal hai nichu jaat ka insaan hai, bhag yaha se warna mar k bhaguan" (used very bad slang language). In between the said incident they all called their family members and assaulted us I & my brother many times requested them in folded hands to stop but they didn't listen to us. I was totally shocked as I have never fallen into such situation. Due to their this
