WE74BE2801 dashed my son, by rash and negligent driving causing him to be thrown onto the side of the road, where he sustained serious and bloody injuries. The local people took my son to Bagdogra Health Centre from where he referred to NBMC & Hospital for better treatment where he was admitted for treatment but he couldn't survive and succumbed to his death.
