In producing herewith the accused person named Rabi Oraon, aged 20 years, s/o- Kalu Oraon, resident of Kamalour Tea estate PS- Bagdogra, Dist- Darizeling (not verified) under custody along with the \_\_wing seized articles under proper s \_\_we list:

1. One iron made single barrel country-made improvised firearms locally called as 'Desi Katta' measuring total legger 28 cm having barrel length 15 cm. with one active hammer, one firing pin, one trigger and butt covered with wood and marked as Exhibit-A (recovered & seized from the front waist concealed under wearing apparels of Rabi Oraon).

2. One 7.7 mm X 56 mm live ammunition measuring length 7 CM and marked as Exhibit-B (recovered & seized from the left pocket of pant of Rabi Oraon).

I, ASI Amit Lama of Bagdogra PS, S.P.C. do hereby lodge this written complaint against the above noted arrested accused Rabi Oraon, aged 20 years, s/o- Kalu Oraon, resident of Kamalpur Tea estate, PS- Fagdogra, Dist- Darjeeling to the effect hat today on 09.10.2025 at 21:05 hrs I received credible source information that one suspect carrying & possessing firearms & ammunitions has been waiting at Singhijhora more beside AH-02 under Bagdogra PS jurisdiction to sell firearms to his designed customer for his wrongful gain. He can be caught red-handed with illegal firearms if raid is conducted immediately. Accordingly, I appraised the matter to O/C Bagdogra PS and diarized the matter in GD vide GDE No. 358 dated 09.10.2025. Then as per direction of O/C Bagdogra PS, I formed a team with SI Binup Mahato, SI Debabrata Kundu, ASI Munna Ahmed, C/1509 Sourav Roy Sarkar, CV/375 Jogesh Barman & CV/389 Janak Singh headed by me and left for Singhijhora more beside AH-02 under Bagdogra PS with relevant documents, articles to work out the secret source information vide MCC No. 22 1/25 dated 09.10.2025. This refers to Bagdogra PS GDE No. 359 dated 09.10.2025. On the way we contacted with two independent witnesses named Md. Ramzan, aged 24 years, s/o- Late Md. Fakira, resident of Pramod Nagar, PS- Bagdogra, Dist- Darjeeling (Ph. No. 74701-11840) and Barun Rey, aged 20 years, s/o- Ram Sogarath Roy, resident of Singhijhora Tea Estate, PS-Bagdogra, Dist- Darjeeling (Ph. No. 82070-74702) and they expressed their willingness to be present as independent witness. At around 21:35 hrs we reached near Singhijhora more beside AH-02 under Bagdogra PS and ambushed there. After a few times, source indicated the suspect and as per identification and indication by source, at 21.53 hrs we apprehended one person their in presence of independent witnesses. We disclosed the identity of our raiding team and the input we had to the suspent and interrogated him. On interrogation, he revealed his identity as Rabi Oraon, aged 20 years, s/o- Kalu Oraon, resident of Kamapur Tea estate, PS- Bagdogra, Dist-Darjeeling. Subsequently, we searched his persons in presence of independent witnesses. On search, one iron made improvised firearms & on live ammunition were recovered from his possession. The firearm was kept concealed on 1 s front waist concealed under his w aring the live ammunition was recover from his left pocket of pant. On along interroge on a disclosed that he had been carting a possessing the said improvised fireacts with live unanunities procured illegally from B far (a) Rs. 6000/- and he had been waiting there for an hour in order to sell the firearms & ammunition to his designed customer who would come from Siliguri for his wrongful gain. On demand, he failed to produce any valid license/document for possessing & carrying firearms & live ammunition. Subsequently, I measured the recovered firearms & ammunition. Then I seized the recovered firearms & the live ammunition from his exclusive possession under proper seizure list and labeled the same in

presence of independent witnesses. At last, I arrested the above mentioned accused person after communicating him the ground of arrest in writing as he has committed a cognizable offence in presence of Police Officer for possessing and carrying illegal firearms with live ammunition to prevent the accused person from committing any further offence, to prevent him to cause disappearance of evidence as well as for proper investigation of the case and issued memo of arrest in the regard. The entire process of search, sizure & arrest is done in between 21 shrs & 22: as on 09.10.2025 through audio-vide electronic means using Govt. mobil pp WE F-Shaksiya vides Evidence Certificate Nos. C-359-17327-20231009221237 and C-359-17329-20231009221324.

Therefore, I request you to initiate a specific case under proper sections of law against the involved accused person Rabi Oraon, aged 20 years, s/o- Kalu Oraon, resident of Kamalpur Tea estate, PS- Bagdogra, Dist- Darjeeling (not verified) and arrange for its investigation.
