Sir,
I, Pem Doma Panlook, wife of Sri Tsheten
Engdi Panlook, Age-65, Resident of Sivasika
Apartment, 2½ Nilo, Suvoke Road, Siliguri, would like
to report that a sum of Rs. 7,09,000/- (Rupees Seven
lakh Nine thousand only) was withdrawn through fraudulent
means which may come under Cyber Crime. The amount
was withdrawn from my account with Bank of India,
Gangtok Branch. It all happened while I was trying to
download SBI Yono App from Facebook. In the process
there was a call from 92341 35765, 62047 80232, mobile
registered numbers from persons who pretended to be the staff of
SBI who wanted to assist me to download the app.
They requested me to give the details of the SBI ATM
Card. Since I do not have SBI ATM Card, they wanted
details of other ATM Card that I was currently using.
In this process I gave them my Bank of India
ATM Card details. After that I was busy arranging
birthday celebration of my daughter since some relatives
had been invited. Next day, on 12/10/2025, I realised
that above amount was withdrawn in multiple transactions
which are reflected in the enclosed bank statement.

I immediately informed 1930 The Cyber Crime
Helpline. They responded providing me a form to fill in
and for immediate submission. Accordingly, I submitted
the form and got received acknowledgement instantly.
I have also informed my bank immediately.
Therefore I request you to take necessary steps.
